## **SYNOPSIS**

Petitioner sought to compel the respondent Board to set a school year start date on or after September 1 rather than the August 24, 2011 date which petitioner alleged was arbitrarily imposed. A motion for emergent relief in this matter was denied on July 8, 2011 as untimely. The case continued in the Office of Administrative Law (OAL) to determine whether any further issue needed to be decided, and to conclude the case.

The ALJ found that: the threshold matter in this case is the timeliness of petitioner's appeal; the Board took action at a public meeting on September 21, 2010 which established August 24, 2011 as the first day of school for the 2011-2012 school year; pursuant to *N.J.A.C.* 6A:3-1.3(i), the 90-day window for filing a challenge to this action was December 20, 2010; and petitioner did not file the instant petition until June 3, 2011. Accordingly, the ALJ concluded that the petition was clearly out of time, and dismissed the petition.

Upon consideration, the Commissioner concurred with the ALJ that the petition was not timely filed in accordance with *N.J.A.C.* 6A:3-1.3(i) and dismissed the appeal.
