SUBJECT: State Board of Examiners

I recommend the adoption of the attached resolution confirming three reappointments to the State Board of Examiners.

N.J.S.A. 18A:6-38 provides the State Board of Examiners with authority for issuing, revoking and suspending educational certificates under rules prescribed by the State Board of Education. Pursuant to N.J.S.A. 18A:6-34, the membership of the State Board of Examiners shall include an assistant commissioner, a county superintendent, two state college presidents, two school district superintendents, a high school principal, an elementary school principal, a business administrator, a librarian and four teaching staff members.

In accordance with N.J.S.A. 18A:6-34 and 35, all members of the State Board of Examiners shall be appointed by the Commissioner of Education with the approval of the State Board of Education for a term of two years. There are 14 positions on the board whose terms expire on a staggered schedule. Members may be reappointed at the conclusion of their two-year terms. Attached is a roster of the current membership.

In adopting the attached resolution, the State Board of Education would approve the reappointments of Gail Cropper, JoAnn Gales and James Gay.
