CONVENING

State Board of Education President Mark Biedron convened the public meeting at 9:00 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

The Open Public Meetings Act was enacted to insure the right of the public to have advance notice of and to attend the meeting of public bodies at which any business affecting their interest is discussed or acted upon.

In accordance with the provisions of this Act, the State Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted in the Department of Education, Secretary of State's Office and notice also having been given to the State House Press Corps, the Governor's Office and the State Board agenda subscribers.

And seeing there was a quorum, the meeting of May 3, 2017, was called to order.

ADJOURN TO EXECUTIVE SESSION

President Biedron then read the resolution pertaining to the executive session of the State Board meeting as it complies with the Open Public Meetings Act.

WHEREAS, in order to protect the personal privacy and to avoid situations wherein the public interest might be disserved, the Open Public Meetings Act permits public bodies to exclude the public from that portion of a meeting at which certain matters are discussed, now therefore be it

RESOLVED, that consistent with the provision of N.J.S.A. 10:4-12.b, the State Board Education will now adjourn to executive session to discuss personnel and legal issues. The State Board immediately adjourned to executive session on May 3, 2017.

RECONVENING

President Biedron reconvened the open meeting at 10:00 a.m. with the reading of the resolution pertaining to the resumption of the public session of the State Board meeting as it complies with the Open Public Meetings Act.

WHEREAS, consistent with the provision of N.J.S.A. 10:4-12.b, the State Board will now adjourn from executive session to resume the open session of this meeting.

PLEDGE OF ALLEGIANCE

APPROVAL OF MINUTES OF THE MEETINGS

On a motion duly seconded and carried, the State Board members approved the minutes of the public meeting conducted on April 5, 2017. State Board member Andy Mulvihill abstained.

PRESIDENT'S REPORT

Public Testimony

President Biedron stated public testimony would be held today at 2 pm. He also stated that the topics for the May 3 public testimony session include amendments to the Educational Facilities (Lead Testing) regulations, amendments to the Evaluation of the Performance of School District (NJQSAC) regulations and amendments to the Controversies and Disputes regulations. He further stated that the May 5 public testimony was an Open Topic Public Testimony session meaning that registered members of the public could speak on any educational topic of their choice.

President Biedron stated that public testimony would be held on June 7, 2017 following the monthly public meeting of the State Board. He also stated that the topics for the June 7, 2017 public testimony session include the amendments to the Career and Technical Education regulations pertaining to Private Career Schools, amendments to the Regulatory Equivalency and Waiver regulations, amendments to the Marie Katzenbach School for the Deaf regulations and amendments to the Programs to Support Student Development (ABR) Notice of Substantive Change regulations.

He further stated that registration for the June 7, 2017 public testimony session would open on Thursday, May 11, 2017 and close at noon on Thursday, May 25, 2017.

President Biedron stated that anyone interested in speaking at or also attending the public testimony session must register so the State Board staff can make proper arrangements for space. Permanent Student Representative

President Biedron welcomed Ava Rybicki the 2016-2017 permanent student representative to the State Board of Education. Ava Rybicki is a senior from Williamstown High School in Gloucester County. President Biedron also introduced Ava's mother Erin Rybicki. Ava spoke to the State Board about her ideas for encouraging NJ college-bound students to remain in NJ for college.

Selection of the State Board Nominating Committee

President Biedron announced the selection of the State Board Nominating Committee that will nominate the 2017-2018 State Board of Education president and vice president. Edithe Fulton will serve as chairperson, and Arcelio Aponte and Ernest Lepore will serve as members. The nominating committee will give its report at the June State Board monthly meeting and the State Board will vote on officers at the July State Board monthly meeting.

Resolution to Establish the State Board Calendar of Meeting Dates for 2017-2018

President Biedron presented the draft monthly public meeting dates calendar for the 2017-2018 school year. The State Board plans to adopt a resolution at its June 7, 2017 monthly public business meeting regarding the annual calendar of the 2017-2018 meeting dates of the State Board of Education pursuant to N.J.A.C. 6A:1-2.2, N.J.S.A. 18A:4-7 and 10:4-6 et seq.

Resolution to Recognize May 2017 at Physical Education and Sport Month

President Biedron presented a resolution to recognize May 2017 as Physical Education and Sport month. On a motion duly seconded and carried, the State Board approved the following resolution read by State Board member Edithe Fulton:

RESOLUTION TO RECOGNIZE MAY 2017 AS PHYSICAL EDUCATION AND SPORT MONTH

WHEREAS, childhood obesity has reached epidemic proportions in the United States: and New Jersey has the highest obesity rate in the nation among low-income children; and

WHEREAS, today's childhood obesity rates are putting our children on course to be the first generation in this country to live shorter and less healthy lives than their parents; and

WHEREAS, children spend many of their waking hours at school and therefore need to be active during the school day to meet the recommendations of the Physical Activity Guidelines for Americans; and

WHEREAS, the U.S. Department of Health and Human Services recommends that young people aged 6–17 years participate in at least 60 minutes of physical activity daily; and

WHEREAS, N.J.S.A.18A:35 7-8 requires all students in grades 1-12 to participate in at least 150 minutes per week of health, safety and physical education; and

WHEREAS, research shows that physically active children are more likely to thrive academically and have improved behavior in school; and

WHEREAS, schools can promote physical activity through comprehensive school physical activity programs, including recess, classroom-based physical activity, intramural physical activity clubs, interscholastic sports, and physical education; and

WHEREAS, participation in sports teams and physical activity clubs, can improve grade point average, school attachment, educational aspirations and the likelihood of graduation; and

WHEREAS, higher physical fitness achievement is associated with better school attendance rates and fewer disciplinary incidents involving drugs, alcohol, violence or truancy;

WHEREAS, the New Jersey State Board of Education strongly supports efforts to increase physical education, physical activity and participation in youth sports, recognizes the month of May as National Physical Education and Sport Month; now therefore be it

RESOLVED, that the New Jersey State Board of Education designates the week of May 1-7, 2017 as National Physical Education and Sport Week and recognizes National Physical Education and Sport Month and the central role of physical education and sports in creating a healthy lifestyle for all children in the State of New Jersey.

ISTEAM TEAM

Maria Gallagher, a Gifted and Talented Teacher and Coach for the ISTEAM TEAM, Evesham Township School District presented the ISTEAM team to the State Board. The ISTEAM students provided an overview of the Steam Tank program which showcased methods they have developed to encourage people to use food before it goes to waste.

**A RESOLUTION SUPPORTING SOCIAL AND EMOTIONAL COMPETENCIES
FOR NEW JERSEY SCHOOLS**

WHEREAS, students come to school with a variety of experiences, barriers and abilities that may impact readiness to learn; and

WHEREAS, schools that foster positive climates are characterized by people feeling socially, emotionally and physically safe; students and staff that are held to high expectations; and access to supportive programs and initiatives to assist students to reach their full potential; and

WHEREAS, social and emotional learning supports a positive school climate, reduces barriers to learning, increases school connectedness and is critical to success in school and life; and

WHEREAS, social and emotional learning skills, knowledge and attitudes can be acquired and are an integral part of education from preschool through Grade 12; and

WHEREAS, social and emotional learning is necessary for students to understand and manage emotions, set and achieve positive goals, feel and show empathy for others, establish and maintain positive relationships, and make responsible decisions; and

WHEREAS, research demonstrates that social and emotional learning increases students' attendance; decreases conduct problems; improves grades and test scores; and reduces at-risk behaviors; and

WHEREAS, schools that embed and teach social and emotional learning skills across all subject areas facilitate students' academic success and social development; and

WHEREAS, the New Jersey Department of Education and stakeholders from across the State collaboratively developed the *New Jersey Social and Emotional Learning Competencies* to support school districts in their efforts to build and deepen positive school climates; now therefore be it

RESOLVED, that the Commissioner of Education and the New Jersey State Board of Education recommend school districts implement the *New Jersey Social and Emotional Learning Competencies* to promote safe, supportive and challenging learning environments.

***E. Religious Holidays Calendar**

- Adopted the following resolution pertaining to the annual calendar of religious holidays for the 2017-2018 school year as established at N.J.A.C. 6A:32-8.3(j), pursuant to N.J.S.A. 18A:36-14-16.

RESOLUTION

The List of Religious Holidays Permitting Student Absence from School

WHEREAS, according to N.J.S.A. 18A:36-14 through 16 and N.J.A.C. 6A:32-8.3(j), regarding student absence from school because of religious holidays, the Commissioner of Education, with the approval of the State Board of Education, is charged with the responsibility of prescribing such rules and regulations as may be necessary to carry out the purpose of the law; and

WHEREAS, the law provides that:

1. Any student absent from school because of a religious holiday may not be deprived of any award or of eligibility or opportunity to compete for any award because of such absence;

2. Students who miss a test or examination because of absence on a religious holiday must be given the right to take an alternate test or examination;
3. To be entitled to the privileges set forth above, the student must present a written excuse signed by a parent or person standing in place of a parent;
4. Any absence because of a religious holiday must be recorded in the school register or in any group or class attendance record as an excused absence;
5. Such absence must not be recorded on any transcript or application or employment form or on any similar form; and
6. The Commissioner, with the approval of the State Board of Education, is required to:
 - (a) prescribe such rules and regulations as may be necessary to carry out the purposes of this act; and
 - (b) prepare a list of religious holidays on which it shall be mandatory to excuse a student. The list, however, is to be a minimum list. Boards of education, at their discretion, may add other days to the list for the schools of their districts; and

WHEREAS, although the New Jersey Department of Education makes every attempt to ensure the accuracy of the dates using the lunar, Gregorian and Julian calendars; and

WHEREAS, dates within this resolution may not be fixed before the State Board adopts the annual calendar and may require additional revision; now therefore be it

RESOLVED, the State Board of Education permits the Commissioner of Education, after annual adoption by the State Board of Education, to revise the dates provided in list of religious holidays.

WHEREAS, the district board of education has the right to add any bona fide religious holiday to the list for its own schools; now therefore be it,

RESOLVED that the State Board of Education adopts the following list of religious holidays for the 2017 - 2018 school year:

***F. City of Newark – School Qualified Bonds**

- Adopted the following resolution approving the April 21, 2017, amended application to allow the City of Newark to issue \$30,582,031 of School Qualified Bonds, pursuant to N.J.S.A. 18A:24-88(b).

**RESOLUTION FOR CITY OF NEWARK \$30,582,031 SCHOOL QUALIFIED BONDS
AMENDED APPLICATION**

WHEREAS, the issue before the New Jersey State Board of Education is on the amended application of the Newark School District (“District”) as to whether the City of Newark in the County of Essex, New Jersey (“City”) is entitled to issue \$30,582,031.00 of School Qualified Bonds (the “Bonds”) on behalf of the District as qualified bonds pursuant to the School Qualified Bond Act, N.J.S.A. 18A:24-85 et seq.; and

WHEREAS, the authority of the State Board is established pursuant to N.J.S.A. 18A:24-88c. when an investigation shows to the satisfaction of the Commissioner that such school district or municipality should be entitled to issue qualified bonds pursuant to the provisions of N.J.S.A. 18A:24-85 et seq. he shall so recommend to the State Board which may by resolution determine that such school district or municipality is entitled to issue qualified bonds; and

WHEREAS, the Bonds would still be issued for the purpose of improving various schools of the District; and

WHEREAS, qualified bonds are those where the credit status is strengthened by a pledge of State school aid to guarantee debt service payments on the bonds, and entail the State Treasurer withholding State school aid to be held in trust to pay the debt service, with the City, as issuer, replenishing the State school aid by repaying the debt service on the Bonds; and

WHEREAS, on December 14, 2016, the Capital Project Control Board agreed to finance various capital improvements to be undertaken by the District and then on April 11, 2017 amended the various capital improvements; and

WHEREAS, on or about May 3, 2017, the City will introduce a bond ordinance appropriating \$30,582,031 on behalf of the District for the issuance of the school qualified bonds; and

WHEREAS, on January 4, 2017, the District submitted its original application to the Commissioner for investigation and recommendation and a determination by the State Board of Education and then subsequently submitted an amended application on April 21, 2017 for the same; and

WHEREAS, the bond ordinance will be finally adopted after approval has been granted by both the State Board of Education and the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs; and

WHEREAS, in accordance with N.J.S.A. 18A:24-88b, the Department undertook an investigation of the statutory factors to be considered in making a recommendation on the amended application to the State Board; and

WHEREAS, the Commissioner found that all of the express statutory factors at N.J.S.A. 18A:24-88b supported a positive recommendation on qualification; and

WHEREAS, the Commissioner believes that the bonds to be issued by the City will support the ability of the District to maintain a thorough and efficient system of education; and

WHEREAS, pursuant to N.J.S.A. 18A:24-88(c), the Commissioner has undertaken an investigation of the statutory factors and now recommends to the State Board of Education that the City should be entitled to issue qualified bonds in conjunction with the Newark School District's Capital Bond Proposal dated January 4, 2017 in the amount of \$30,582,031.00 and as amended in the revised application dated April 21, 2017, now, therefore, be it

RESOLVED, that the New Jersey State Board of Education, upon the recommendation of the Commissioner has determined that the City is entitled to issue qualified bonds in conjunction with the Newark School District's Capital Bond Proposal dated January 4, 2017 in the amount of \$30,582,031.00 and as amended in the revised application dated April 21, 2017.
