The 2011 EMP is insufficient as regards climate change mitigation. More needs to be done, and faster - not less done slower. All indications are that the Governor and his administration will continue to ignore this truth in the present (2015) EMP review cycle. Instead of relaxing goals and perverting the definition of "clean energy" to include nuclear and natural gas, we need to be totally "aspirational," setting goals which will challenge all minds in the state to the intellectual and practical achievements of our Einstein and Edison.

350NJ aligns itself with the scientifically based perspective that an atmospheric concentration of carbon dioxide of 350 ppmv is appropriate for sustainable human civilization. Currently, that concentration stands at about 400 ppmv. (CO2Now) This lends extreme urgency to our campaigns to transition the economy from such a heavy reliance on carbon combustion as an energy source.

## Observations:

The current Energy Master Plan was adopted in 2011. Since that time, the world has changed. Superstorm Sandy ravaged NJ mere months (October 29, 2011) after the summer hearings on the draft EMP. Price reductions on renewable generation (Parkinson, 2015) and increasing success in other countries in meeting their energy needs wholly with renewable resources (e.g., Denmark) dominate the news. (Nelson, 2015) The domestic nuclear fleet continues to age inexorably (here in New Jersey: Oyster Creek - 46 years; Salem Unit 1 - 38 years; Salem Unit 2 - 35 years; Hope Creek - 29 years). Lessons remain to be learned and applied relative to the Fukushima Daiichi accidents. The Vatican has issued a clear call for renewed respect and concern for the environment. (Francis, 2015) Meanwhile, the aggravated annual recession of Arctic sea ice, the continuing acidification of global oceans, and the dissipation of mountain glaciers - among other effects - amplify with increasing despair the grave global disruptions which humans continue to preside over. We are not in a time of stable ecosystems. We are witnessing collapse - collapse which is caused – to a significant extent - by ourselves.

NJ stands near the back of the line among the US states as regards the use of renewable resources for its energy needs. While, according to the most recent available data (2011) shown at a federal website (US Department of Energy, Office of Energy Efficiency & Renewable Energy, 2015), NJ ranks 20th for statewide energy consumption (kWh basis), the state ranks 47th in electricity generation from renewable energy resources (and 7th for solar generation and 36th for wind generation). Among the group of states including NJ, benchmark states CA and TX, and its neighbors PA and NY, NJ ranks last in terms of overall electricity generated by renewables and last in terms of wind-based electricity generation (by orders of magnitude, here). See the data below. Any celebration of the state's renewables' progress has been falsely advanced.

The current EMP echoes a "renewable portfolio standard" goal of 22.5% by 2020. It is not clear where NJ presently stands relative to this goal. California – a national leader in the deployment of renewable energy – has already achieved levels in excess of 22% in their program and are targeted on achieving 33% by 2020. (California Public Utilities Commission, 2015)

The identified emerging issues for 2015 seem primarily focused on adaptation to the impacts of climate change:

- 1. Protecting critical energy infrastructure;
- 2. Improving the Electric Distribution Companies' emergency preparedness and response;
- 3. Increasing the use of microgrid technologies and applications for distributed energy resources (DER);
- 4. Creating long-term financing for resiliency measures through the Energy Resilience Bank.

The imperative of mitigation - meaning stabilization of carbon emissions and eventual reduction to 350 ppmv levels - is absent.

At this time, there appears to be little quantitative connection between the state's climate objectives and the energy master plan. One becomes confused tracking various goals, commitments, and statuses between climate programs and the EMP. Further, a direct linkage between climate objectives and energy objectives is not apparent. This is a critical deficiency.

As we know, energy generation and consumption are primary causes of emissions of carbon dioxide  $(CO_2)$  – the principle greenhouse gas.

By adding both nuclear energy and natural gas fired energy to the definition of "clean energy" and counting them towards the 70% goal for "clean" energy sources by 2050 (Solomon, 2011), the Administration has perverted the goals of the clean energy program and is shirking its responsibilities to the residents of the state. Rather than using these false approaches to meet our objectives, we need to stretch forward towards truly clean energy.

Natural gas may be a "bridge" - but must remain a short term one, only. Otherwise, its use becomes a bridge to calamity. As has been amply documented, significant methane leakage occurs during extraction, processing, transmission, distribution and use. (Vaidyanathan, 2015) The high global warming potential of methane dictates that the impacts of leakage be included as CO<sub>2</sub>e and accounted for in all energy and climate analyses.

Continued reliance on nuclear is imperiling, not stabilizing. The fact that over half of the state's indigenous electrical generation is nuclear is a troublesome realization, given the age of those generators, the impending shutdown of one reactor, the unresolved waste disposal issue, and the substantial risks inherent in nuclear energy.

Mechanisms to begin to account for the societal impacts – costs – of human-caused global warming have been developed. (Social Cost of Carbon, 2015) This component is variously referred to SC-CO<sub>2</sub> and SCC. It is not clear that this non-traditional but now-necessary cost component is included in all economic evaluations relating to energy choices.

The world is changing. New Jersey's Energy Master Plan is not properly aligned with reality and current needs. A total overhaul is urgently needed and is called for.

## Suggestions for the 2015 EMP Update:

Let's create a new EMP, to integrate climate stabilization goals with the energy vision for the next decades.

Let's revise the goals of the EMP to explicitly state climate mitigation as a central goal and pervasive focus.

Let's set quantitative CO<sub>2</sub>e targets and tweak the energy choices as a dependent variable to those emission targets.

Let's promote environmental objectives ahead of economic ones.

Let's clean up the definition of "clean energy" - as used in this plan - to eliminate both nuclear energy and the long-term use of natural gas.

Let's account for the climate-killing emissions of methane inherent in the exploitation of natural gas in all scenarios which involve the use of that energy source.

Let's include the very real societal costs of carbon emissions in all economic assessments.

Let's boldly stipulate that NJ's electric generation be fossil-fuel-free [FFF] (and nuclear-free) by 2030 and that adequate systems be in place in NJ for FFF transport and heating by 2050.

Let's foster the interagency coordination (BPU, DEP, DOT, NJ-Transit, and others) needed to afford concurrent management of climate emissions as an underlying governmental priority.

## In Closing:

We need bold, determined leadership in the energy planning arena. Gone are the days when incremental changes are good enough. We need quantum-change thinking.

Are we going to continue digging ourselves into a deepening pit of fossilized carbon and global warming or are we ready to come up for fresh air and sunshine?
