- ▶ Is a Green Community Model



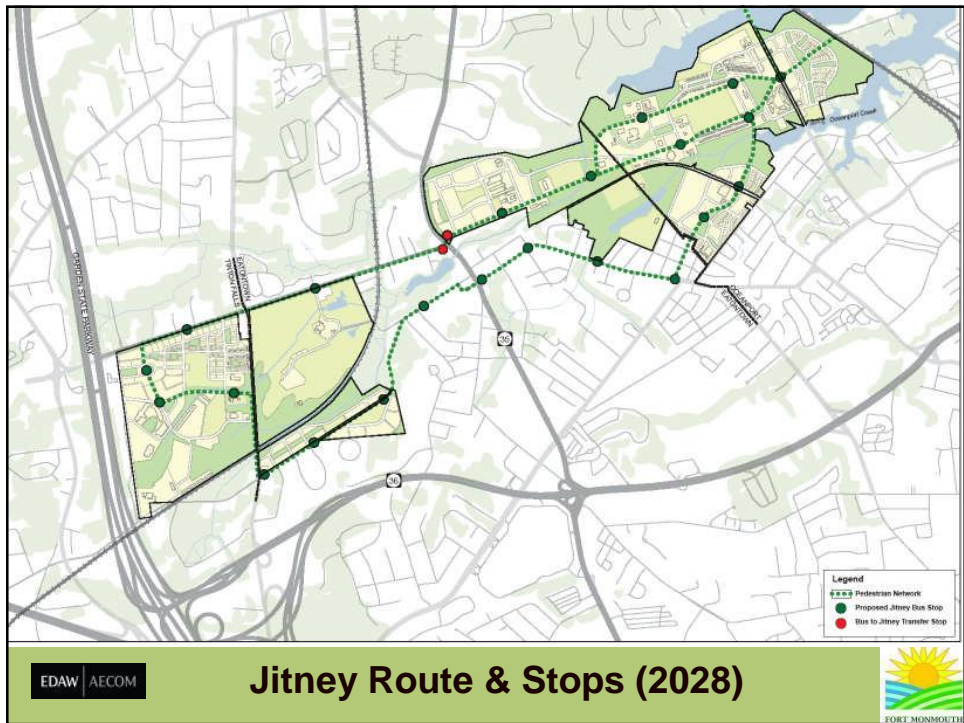
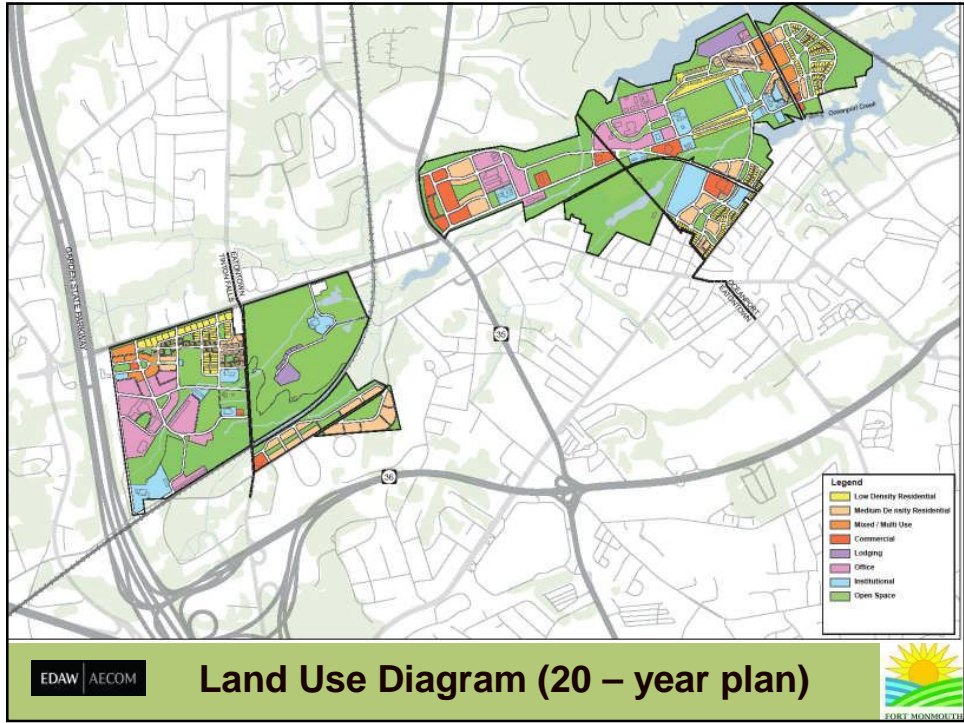

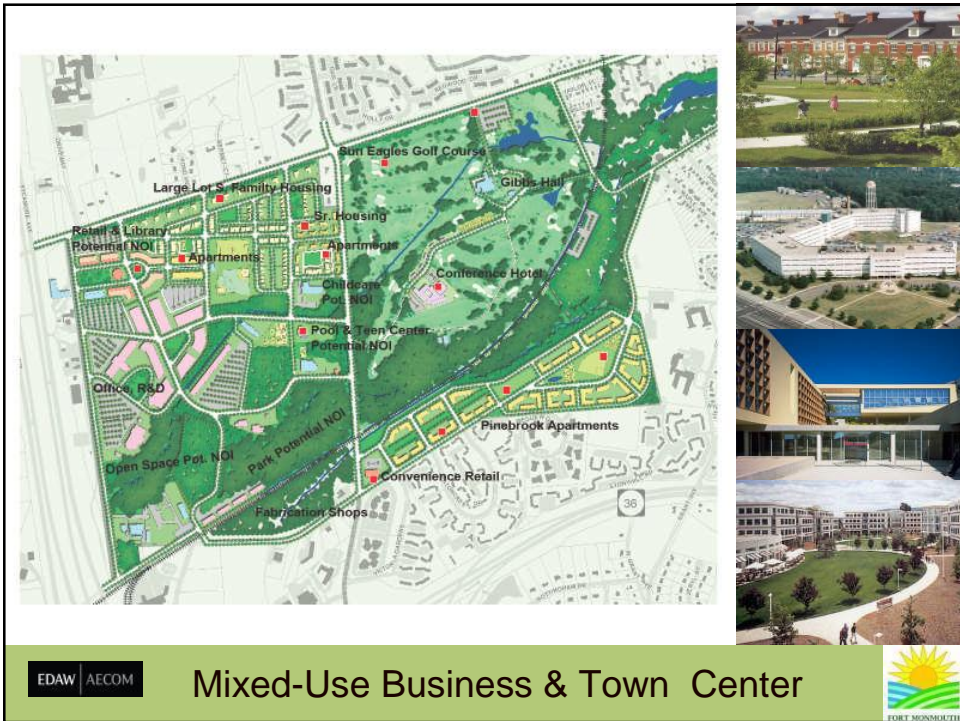

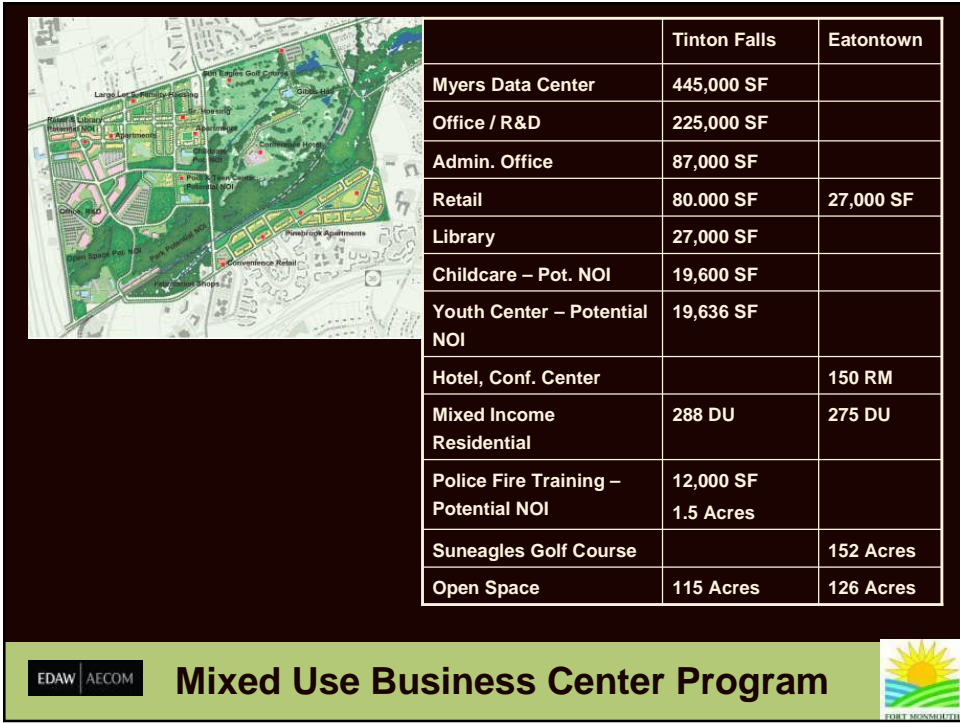
Street Typology Plan (2028)



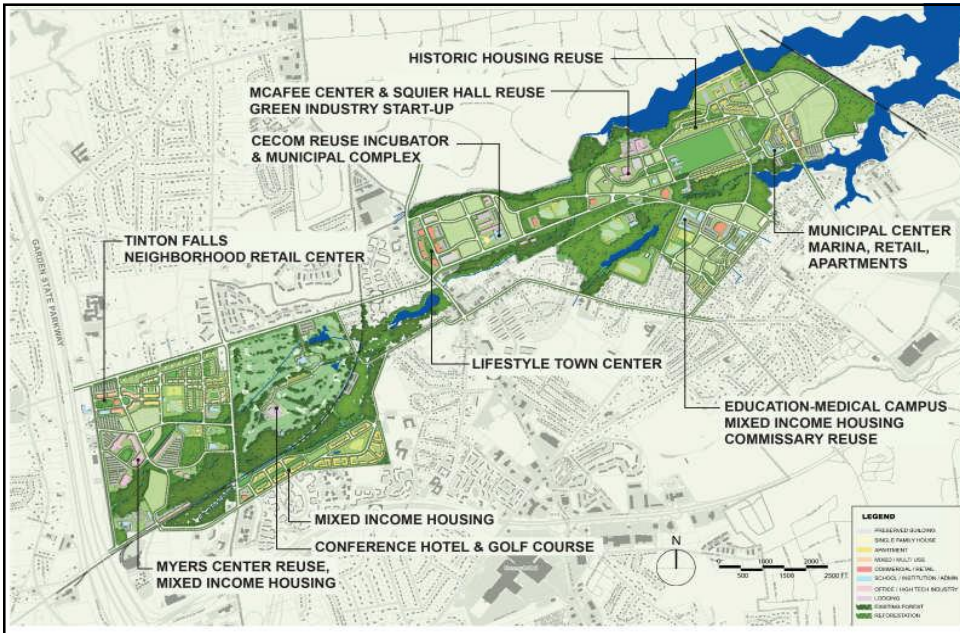

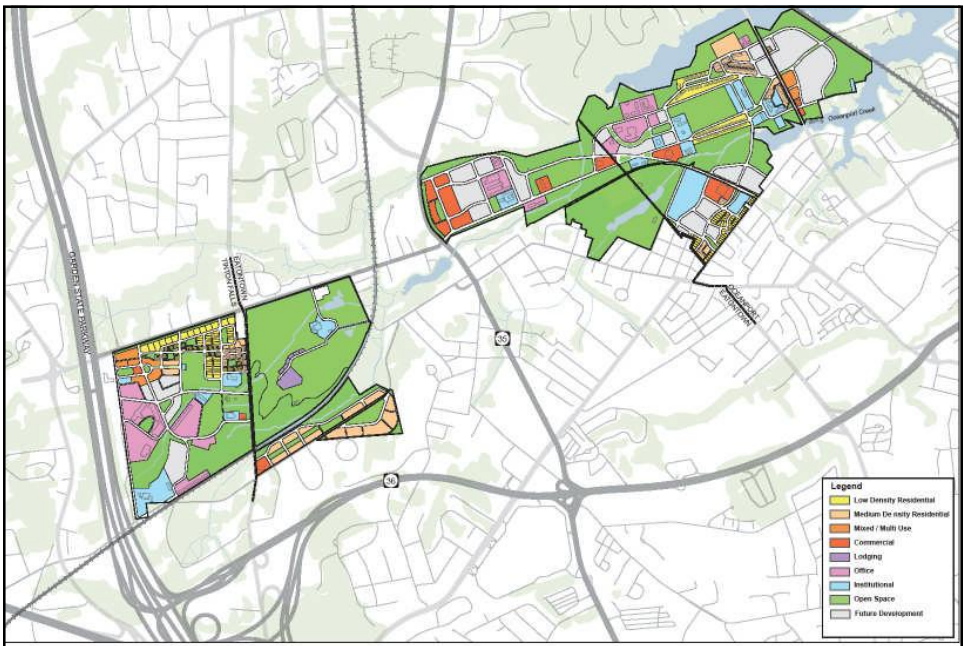
