# **Description and Use**

**Methidathion** is a colorless, odorless, crystalline solid which is often dissolved in a liquid "carrier." It is an *Organophosphate* pesticide used for scale insects, spider lice and other insects.

# **Reasons for Citation**

- ► Methidathion is on the Right to Know Hazardous Substance List because it is cited by DOT, DEP, IRIS and EPA.
- ► This chemical is on the Special Health Hazard Substance List

# **FIRST AID**

# **Eye Contact**

▶ Immediately flush with large amounts of water for at least 15 minutes, lifting upper and lower lids. Remove contact lenses, if worn, while flushing. Seek medical attention immediately.

#### **Skin Contact**

- ▶ Quickly remove contaminated clothing. Immediately wash contaminated skin with large amounts of water.
- ▶ Shampoo hair immediately if contaminated.

# Inhalation

- ▶ Remove the person from exposure.
- ▶ Begin rescue breathing (using universal precautions) if breathing has stopped and CPR if heart action has stopped.
- ▶ Transfer promptly to a medical facility.

- ► Methidathion can affect you when inhaled and quickly enters the body by passing through the skin.
- Methidathion should be handled as a CARCINOGEN-WITH EXTREME CAUTION.
- Exposure to Methidathion can cause rapid, FATAL Organophosphate poisoning.
- ► **Methidathion** can irritate and burn the eyes with possible eye damage.
- ► Methidathion can cause nausea, vomiting, diarrhea and abdominal pain.
- ▶ Methidathion may cause a skin allergy.
- High or repeated exposure may damage the nervous system.
- ▶ Repeated exposure may cause personality changes such as depression, anxiety or irritability.
- ► Methidathion does not burn, however it is often dissolved in a liquid carrier which may be flammable or combustible.

# **Workplace Exposure Limits**

No occupational exposure limits have been established for **Methidathion**. However, it may pose a health risk. Always follow safe work practices.

- ► Methidathion may be a CARCINOGEN in humans. There may be no safe level of exposure to a carcinogen, so all contact should be reduced to the lowest possible level.
- ▶ It should be recognized that **Methidathion** can be absorbed through your skin, thereby increasing your exposure.

# **Determining Your Exposure**

- ▶ Read the product manufacturer's Material Safety Data Sheet (MSDS) and the label to determine product ingredients and important safety and health information about the product mixture.
- ► For each individual hazardous ingredient, read the New Jersey Department of Health Hazardous Substance Fact Sheet, available on the RTK website (<a href="www.nj.gov/health/eoh/rtkweb">www.nj.gov/health/eoh/rtkweb</a>) or in your facility's RTK Central File or Hazard Communication Standard file.
- ➤ You have a right to this information under the New Jersey Worker and Community Right to Know Act, the Public Employees Occupational Safety and Health (PEOSH) Act if you are a public worker in New Jersey, and under the federal Occupational Safety and Health Act (OSHA) if you are a private worker.
- ▶ The New Jersey Right to Know Act requires most employers to label chemicals in the workplace and requires public employers to provide their employees with information concerning chemical hazards and controls. The federal OSHA Hazard Communication Standard (29 CFR 1910.1200) and the PEOSH Hazard Communication Standard (N.J.A.C. 12:100-7) require employers to provide similar information and training to their employees.

This Fact Sheet is a summary of available information regarding the health hazards that may result from exposure. Duration of exposure, concentration of the substance and other factors will affect your susceptibility to any of the potential effects described below.

# **Health Hazard Information**

#### **Acute Health Effects**

The following acute (short-term) health effects may occur immediately or shortly after exposure to **Methidathion**:

- Exposure can cause rapid, FATAL Organophosphate poisoning with headache, dizziness, constricting of the pupils (miosis) with blurred vision, tightness in the chest, sweating, muscle twitching, loss of coordination, convulsions, coma and death.
- Methidathion can irritate and burn the eyes with possible eye damage.
- ► Methidathion can cause nausea, vomiting, diarrhea and abdominal pain.

#### **Chronic Health Effects**

The following chronic (long-term) health effects can occur at some time after exposure to **Methidathion** and can last for months or years:

#### Cancer Hazard

- ► Methidathion may be a CARCINOGEN in humans since it has been shown to cause lung cancer in animals.
- ► Many scientists believe there is no safe level of exposure to a carcinogen.

## Reproductive Hazard

► There is no evidence that **Methidathion** affects reproduction. This is based on test results presently available to the NJDOH from published studies.

#### Other Effects

- ▶ Methidathion may cause a skin allergy. If allergy develops, very low future exposure can cause itching and a skin rash.
- ► High or repeated exposure may damage the nerves, causing weakness, "pins and needles," and poor coordination in the arms and legs.
- Repeated exposure may cause personality changes such as depression, anxiety or irritability.

# Medical

#### **Medical Testing**

Before employment and at regular times after that, the following are recommended:

- ▶ Plasma and red blood cell cholinesterase levels (tests for the enzyme poisoned by this chemical). If exposure stops, plasma levels return to normal in 1-2 weeks, but red blood cell levels may be reduced for 1-3 months.
- When cholinesterase enzyme levels are reduced by 25% or more below pre-employment levels, risk of poisoning is increased, even if results are in lower ranges of "normal." Reassignment to work not involving *Organophosphate* or *Carbamate* pesticides is recommended until enzyme levels recover.

If symptoms develop or overexposure occurs, repeat the preceding tests as soon as possible and get an exam of the nervous system. Also consider:

 Evaluation by a qualified allergist can help diagnose skin allergy.

Any evaluation should include a careful history of past and present symptoms with an exam. Medical tests that look for damage already done are <u>not</u> a substitute for controlling exposure.

Request copies of your medical testing. You have a legal right to this information under the OSHA Access to Employee Exposure and Medical Records Standard (29 CFR 1910.1020).

# **Workplace Controls and Practices**

Very toxic chemicals, or those that are reproductive hazards or sensitizers, require expert advice on control measures if a less toxic chemical cannot be substituted. Control measures include: (1) enclosing chemical processes for severely irritating and corrosive chemicals, (2) using local exhaust ventilation for chemicals that may be harmful with a single exposure, and (3) using general ventilation to control exposures to skin and eye irritants. For further information on workplace controls, consult the NIOSH document on Control Banding at www.cdc.gov/niosh/topics/ctrlbanding/.

The following work practices are also recommended:

- ▶ Label process containers.
- ▶ Provide employees with hazard information and training.
- ▶ Monitor airborne chemical concentrations.
- Use engineering controls if concentrations exceed recommended exposure levels.
- ▶ Provide eye wash fountains and emergency showers.
- Wash or shower if skin comes in contact with a hazardous material.
- ▶ Always wash at the end of the workshift.
- Change into clean clothing if clothing becomes contaminated.
- ▶ Do not take contaminated clothing home.
- ▶ Get special training to wash contaminated clothing.
- ▶ Do not eat, smoke, or drink in areas where chemicals are being handled, processed or stored.
- Wash hands carefully before eating, smoking, drinking, applying cosmetics or using the toilet.

In addition, the following may be useful or required:

► For solid **Methidathion**, use a vacuum or a wet method to reduce dust during clean-up. DO NOT DRY SWEEP.

# **Personal Protective Equipment**

The OSHA Personal Protective Equipment Standard (29 CFR 1910.132) requires employers to determine the appropriate personal protective equipment for each hazard and to train employees on how and when to use protective equipment.

The following recommendations are only guidelines and may not apply to every situation.

# **Gloves and Clothing**

- ▶ Avoid skin contact with **Methidathion**. Wear personal protective equipment made from material that can not be permeated or degraded by this substance. Safety equipment suppliers and manufacturers can provide recommendations on the most protective glove and clothing material for your operation.
- Safety equipment manufacturers recommend Polyvinyl Alcohol, Polyvinyl Chloride, Silver Shield®/4H® and Viton for gloves and DuPont Tychem® BR, LV, Responder® and TK; Kappler® Zytron® 300; and Saint-Gobain ONESuit® TEC, or the equivalent, as protective materials for Organophosphorus compounds.
- ▶ All protective clothing (suits, gloves, footwear, headgear) should be clean, available each day, and put on before work.

#### **Eye Protection**

- For solid Methidathion wear eye protection with side shields or goggles.
- ► Wear indirect-vent, impact and splash resistant goggles when working with liquids.
- ► Wear a face shield along with goggles when working with corrosive, highly irritating or toxic substances.

## **Respiratory Protection**

*Improper use of respirators is dangerous.* Respirators should only be used if the employer has implemented a written program that takes into account workplace conditions, requirements for worker training, respirator fit testing, and medical exams, as described in the OSHA Respiratory Protection Standard (29 CFR 1910.134).

- ► For field applications check with your supervisor and your safety equipment supplier regarding the appropriate respiratory equipment.
- ▶ Where the potential for overexposure exists, use a NIOSH approved supplied-air respirator with a full facepiece operated in a pressure-demand or other positive-pressure mode. For increased protection use in combination with an auxiliary self-contained breathing apparatus operated in a pressure-demand or other positive-pressure mode.

# **Fire Hazards**

If employees are expected to fight fires, they must be trained and equipped as stated in the OSHA Fire Brigades Standard (29 CFR 1910.156).

- Solid Methidathion does not burn, however it is often dissolved in a liquid carrier which may be flammable or combustible.
- ► POISONOUS GASES ARE PRODUCED IN FIRE, including Nitrogen Oxides, Sulfur Oxides and Phosphorus Oxides.
- ▶ Use water spray to keep fire-exposed containers cool.

# **Spills and Emergencies**

If employees are required to clean-up spills, they must be properly trained and equipped. The OSHA Hazardous Waste Operations and Emergency Response Standard (29 CFR 1910.120) may apply.

If Methidathion is spilled or leaked, take the following steps:

- Evacuate personnel and secure and control entrance to the area.
- ▶ Eliminate all ignition sources.
- ► Absorb liquids in vermiculite, dry sand, earth, or a similar material and deposit in sealed containers.
- ► For solid **Methidathion** moisten spilled material first or use a HEPA-filter vacuum for clean-up and deposit in sealed containers.
- ▶ Ventilate and wash area after clean-up is complete.
- ▶ DO NOT wash into sewer.
- ▶ It may be necessary to contain and dispose of **Methidathion** as a HAZARDOUS WASTE. Contact your state Department of Environmental Protection (DEP) or your regional office of the federal Environmental Protection Agency (EPA) for specific recommendations.

# Handling and Storage

Prior to working with **Methidathion** you should be trained on its proper handling and storage.

- Methidathion is not compatible with WATER as it may decompose.
- Store in tightly closed containers in a cool, well-ventilated area away from HEAT.
- ▶ When **Methidathion** is dissolved in a *flammable solvent*, sources of ignition, such as smoking and open flames, are prohibited.

#### **GLOSSARY**

**ACGIH** is the American Conference of Governmental Industrial Hygienists. They publish guidelines called Threshold Limit Values (TLVs) for exposure to workplace chemicals.

**Acute Exposure Guideline Levels** (AEGLs) are established by the EPA. They describe the risk to humans resulting from once-in-a lifetime, or rare, exposure to airborne chemicals.

**Boiling point** is the temperature at which a substance can change its physical state from a liquid to a gas.

A **carcinogen** is a substance that causes cancer.

The **CAS number** is unique, identifying number, assigned by the Chemical Abstracts Service, to a specific chemical.

**CFR** is the Code of Federal Regulations, which are the regulations of the United States government.

A combustible substance is a solid, liquid or gas that will burn.

A **corrosive** substance is a gas, liquid or solid that causes destruction of human skin or severe corrosion of containers.

**DEP** is the New Jersey Department of Environmental Protection.

**DOT** is the Department of Transportation, the federal agency that regulates the transportation of chemicals.

**EPA** is the Environmental Protection Agency, the federal agency responsible for regulating environmental hazards.

**ERG** is the Emergency Response Guidebook. It is a guide for emergency responders for transportation emergencies involving hazardous substances.

**Emergency Response Planning Guideline** (ERPG) values are intended to provide estimates of concentration ranges where one reasonably might anticipate observing adverse effects.

A fetus is an unborn human or animal.

A **flammable** substance is a solid, liquid, vapor or gas that will ignite easily and burn rapidly.

The **flash point** is the temperature at which a liquid or solid gives off vapor that can form a flammable mixture with air.

**IARC** is the International Agency for Research on Cancer, a scientific group.

**Ionization Potential** is the amount of energy needed to remove an electron from an atom or molecule. It is measured in electron volts.

**IRIS** is the Integrated Risk Information System database maintained by federal EPA. The database contains information on human health effects that may result from exposure to various chemicals in the environment.

**LEL** or **Lower Explosive Limit**, is the lowest concentration of a combustible substance (gas or vapor) in the air capable of continuing an explosion.

mg/m<sup>3</sup> means milligrams of a chemical in a cubic meter of air. It is a measure of concentration (weight/volume).

A **mutagen** is a substance that causes mutations. A **mutation** is a change in the genetic material in a body cell. Mutations can lead to birth defects, miscarriages, or cancer.

**NFPA** is the National Fire Protection Association. It classifies substances according to their fire and explosion hazard.

**NIOSH** is the National Institute for Occupational Safety and Health. It tests equipment, evaluates and approves respirators, conducts studies of workplace hazards, and proposes standards to OSHA.

**NTP** is the National Toxicology Program which tests chemicals and reviews evidence for cancer.

**OSHA** is the federal Occupational Safety and Health Administration, which adopts and enforces health and safety standards.

**PEOSHA** is the New Jersey Public Employees Occupational Safety and Health Act, which adopts and enforces health and safety standards in public workplaces.

**Permeated** is the movement of chemicals through protective materials.

**PIH** is a DOT designation for chemicals which are Poison Inhalation Hazards.

**ppm** means parts of a substance per million parts of air. It is a measure of concentration by volume in air.

A **reactive** substance is a solid, liquid or gas that releases energy under certain conditions.

**STEL** is a Short Term Exposure Limit which is usually a 15-minute exposure that should not be exceeded at any time during a work day.

A **teratogen** is a substance that causes birth defects by damaging the fetus.

**UEL** or **Upper Explosive Limit** is the highest concentration in air above which there is too much fuel (gas or vapor) to begin a reaction or explosion.

**Vapor Density** is the ratio of the weight of a given volume of one gas to the weight of another (usually *Hydrogen*), at the same temperature and pressure.

The **vapor pressure** is a measure of how readily a liquid or a solid mixes with air at its surface. A higher vapor pressure indicates a higher concentration of the substance in air and therefore increases the likelihood of breathing it in.

# SPILL/LEAKS

#### **Isolation Distance:**

Spill (solid): 25 meters (75 feet)
Spill (liquid): 60 meters (200 feet)
Fire: 800 meters (1/2 mile)

Absorb liquids in vermiculite, dry sand, earth, or a similar material and deposit into sealed containers.

Moisten spilled *solid* material first or use a HEPA-filter vacuum for clean-up and deposit into sealed

containers.

DO NOT wash into sewer. Very toxic to aquatic life.

Begin artificial respiration if breathing has stopped and CPR if necessary.

Transfer promptly to a medical facility.
