# HAZARDOUS SUBSTANCE FACT SHEET

## HAZARD SUMMARY

- \* Cyanuric Fluoride can affect you when breathed in and by passing through your skin.
- \* Contact can cause severe skin burns.
- \* Contact can irritate and burn the eyes, and may cause lacrimation (tearing).
- \* Breathing **Cyanuric Fluoride** can irritate the nose and throat causing coughing and wheezing.

## **IDENTIFICATION**

**Cyanuric Fluoride** is a colorless liquid. It is used in dye manufacturing.

## REASON FOR CITATION

- \* Cyanuric Fluoride is on the Hazardous Substance List because it is regulated by OSHA and cited by DOT, DEP and EPA.
- \* Definitions are provided on page 5.

## HOW TO DETERMINE IF YOU ARE BEING EXPOSED

The New Jersey Right to Know Act requires most employers to label chemicals in the workplace and requires public employers to provide their employees with information and training concerning chemical hazards and controls. The federal OSHA Hazard Communication Standard, 1910.1200, requires private employers to provide similar training and information to their employees.

- \* Exposure to hazardous substances should be routinely evaluated. This may include collecting personal and area air samples. You can obtain copies of sampling results from your employer. You have a legal right to this information under OSHA 1910.1020.
- \* If you think you are experiencing any work-related health problems, see a doctor trained to recognize occupational diseases. Take this Fact Sheet with you.

## WORKPLACE EXPOSURE LIMITS

OSHA: The legal airborne permissible exposure limit (PEL) is 5 mg/m<sup>3</sup>, (as *Cyanide*), averaged over

an 8-hour workshift.

\* The above exposure limit is for <u>air levels only</u>. When skin contact also occurs, you may be overexposed, even though air levels are less than the limit listed above.

### WAYS OF REDUCING EXPOSURE

- \* Where possible, enclose operations and use local exhaust ventilation at the site of chemical release. If local exhaust ventilation or enclosure is not used, respirators should be worn
- \* Wear protective work clothing.
- \* Wash thoroughly <u>immediately</u> after exposure to **Cyanuric Fluoride** and at the end of the workshift.
- \* Post hazard and warning information in the work area. In addition, as part of an ongoing education and training effort, communicate all information on the health and safety hazards of **Cyanuric Fluoride** to potentially exposed workers.

This Fact Sheet is a summary source of information of <u>all</u> <u>potential</u> and most severe health hazards that may result from exposure. Duration of exposure, concentration of the substance and other factors will affect your susceptibility to any of the potential effects described below.

#### HEALTH HAZARD INFORMATION

## **Acute Health Effects**

The following acute (short-term) health effects may occur immediately or shortly after exposure to **Cyanuric Fluoride**:

- \* Contact can cause severe skin burns.
- \* Contact can irritate and burn the eyes, and may cause lacrimation (tearing).
- \* Breathing **Cyanuric Fluoride** can irritate the nose and throat causing coughing and wheezing.

#### **Chronic Health Effects**

The following chronic (long-term) health effects can occur at some time after exposure to **Cyanuric Fluoride** and can last for months or years:

#### **Cancer Hazard**

\* According to the information presently available to the New Jersey Department of Health and Senior Services, Cyanuric Fluoride has not been tested for its ability to cause cancer in animals.

## **Reproductive Hazard**

\* According to the information presently available to the New Jersey Department of Health and Senior Services, Cyanuric Fluoride has not been tested for its ability to affect reproduction.

## **Other Long-Term Effects**

\* No chronic (long-term) health effects are known at this time.

## **MEDICAL**

## **Medical Testing**

There is no special test for this chemical. However, if illness occurs or overexposure is suspected, medical attention is recommended.

Any evaluation should include a careful history of past and present symptoms with an exam. Medical tests that look for damage already done are <u>not</u> a substitute for controlling exposure.

Request copies of your medical testing. You have a legal right to this information under OSHA 1910.1020.

## WORKPLACE CONTROLS AND PRACTICES

Unless a less toxic chemical can be substituted for a hazardous substance, **ENGINEERING CONTROLS** are the most effective way of reducing exposure. The best protection is to enclose operations and/or provide local exhaust ventilation at the site of chemical release. Isolating operations can also reduce exposure. Using respirators or protective equipment is less effective than the controls mentioned above, but is sometimes necessary.

In evaluating the controls present in your workplace, consider: (1) how hazardous the substance is, (2) how much of the substance is released into the workplace and (3) whether harmful skin or eye contact could occur. Special controls should be in place for highly toxic chemicals or when significant skin, eye, or breathing exposures are possible.

In addition, the following control is recommended:

\* Where possible, automatically pump liquid **Cyanuric Fluoride** from drums or other storage containers to process containers.

Good **WORK PRACTICES** can help to reduce hazardous exposures. The following work practices are recommended:

- \* Workers whose clothing has been contaminated by **Cyanuric Fluoride** should change into clean clothing promptly.
- \* Contaminated work clothes should be laundered by individuals who have been informed of the hazards of exposure to **Cyanuric Fluoride**.
- \* Eye wash fountains should be provided in the immediate work area for emergency use.
- \* If there is the possibility of skin exposure, emergency shower facilities should be provided.
- \* On skin contact with **Cyanuric Fluoride**, immediately wash or shower to remove the chemical. At the end of the workshift, wash any areas of the body that may have contacted **Cyanuric Fluoride**, whether or not known skin contact has occurred.
- \* Do not eat, smoke, or drink where **Cyanuric Fluoride** is handled, processed, or stored, since the chemical can be swallowed. Wash hands carefully before eating, drinking, smoking, or using the toilet.

## PERSONAL PROTECTIVE EQUIPMENT

WORKPLACE CONTROLS ARE BETTER THAN PERSONAL PROTECTIVE EQUIPMENT. However, for some jobs (such as outside work, confined space entry, jobs done only once in a while, or jobs done while workplace controls are being installed), personal protective equipment may be appropriate.

OSHA 1910.132 requires employers to determine the appropriate personal protective equipment for each hazard and to train employees on how and when to use protective equipment.

The following recommendations are only guidelines and may not apply to every situation.

## Clothing

- \* Avoid skin contact with **Cyanuric Fluoride**. Wear protective gloves and clothing. Safety equipment suppliers/manufacturers can provide recommendations on the most protective glove/clothing material for your operation.
- \* All protective clothing (suits, gloves, footwear, headgear) should be clean, available each day, and put on before work.

## **Eye Protection**

- \* Wear indirect-vent, impact and splash resistant goggles when working with liquids.
- \* Wear a face shield along with goggles when working with corrosive, highly irritating or toxic substances.

## **Respiratory Protection**

## IMPROPER USE OF RESPIRATORS IS DANGEROUS.

Such equipment should only be used if the employer has a written program that takes into account workplace conditions, requirements for worker training, respirator fit testing and medical exams, as described in OSHA 1910.134.

\* Where the potential for overexposure exists, use a MSHA/NIOSH approved supplied-air respirator with a full facepiece operated in a pressure-demand or other positive-pressure mode. For increased protection use in combination with an auxiliary self-contained breathing apparatus operated in a pressure-demand or other positive-pressure mode.

## **QUESTIONS AND ANSWERS**

- Q: If I have acute health effects, will I later get chronic health effects?
- A: Not always. Most chronic (long-term) effects result from repeated exposures to a chemical.
- Q: Can I get long-term effects without ever having shortterm effects?
- A: Yes, because long-term effects can occur from repeated exposures to a chemical at levels not high enough to make you immediately sick.
- Q: What are my chances of getting sick when I have been exposed to chemicals?
- A: The likelihood of becoming sick from chemicals is increased as the amount of exposure increases. This is determined by the length of time and the amount of material to which someone is exposed.

- Q: When are higher exposures more likely?
- A: Conditions which increase risk of exposure include <a href="https://physical.nd/mechanical\_processes">physical\_and\_mechanical\_processes</a> (heating, pouring, spraying, spills and evaporation from large surface areas such as open containers), and "confined space" exposures (working inside vats, reactors, boilers, small rooms, etc.).
- Q: Is the risk of getting sick higher for workers than for community residents?
- A: Yes. Exposures in the community, except possibly in cases of fires or spills, are usually much lower than those found in the workplace. However, people in the community may be exposed to contaminated water as well as to chemicals in the air over long periods. This may be a problem for children or people who are already ill.

## **Industrial Hygiene Information**

Industrial hygienists are available to answer your questions regarding the control of chemical exposures using exhaust ventilation, special work practices, good housekeeping, good hygiene practices, and personal protective equipment including respirators. In addition, they can help to interpret the results of industrial hygiene survey data.

## **Medical Evaluation**

If you think you are becoming sick because of exposure to chemicals at your workplace, you may call personnel at the Department of Health and Senior Services, Occupational Health Service, who can help you find the information you need.

#### **Public Presentations**

Presentations and educational programs on occupational health or the Right to Know Act can be organized for labor unions, trade associations and other groups.

## **DEFINITIONS**

**ACGIH** is the American Conference of Governmental Industrial Hygienists. It recommends upper limits (called TLVs) for exposure to workplace chemicals.

A carcinogen is a substance that causes cancer.

The **CAS number** is assigned by the Chemical Abstracts Service to identify a specific chemical.

**CFR** is the Code of Federal Regulations, which consists of the regulations of the United States government.

A **combustible** substance is a solid, liquid or gas that will burn.

A **corrosive** substance is a gas, liquid or solid that causes irreversible damage to human tissue or containers.

**DEP** is the New Jersey Department of Environmental Protection.

**DOT** is the Department of Transportation, the federal agency that regulates the transportation of chemicals.

**EPA** is the Environmental Protection Agency, the federal agency responsible for regulating environmental hazards.

A fetus is an unborn human or animal.

A **flammable** substance is a solid, liquid, vapor or gas that will ignite easily and burn rapidly.

The **flash point** is the temperature at which a liquid or solid gives off vapor that can form a flammable mixture with air.

**IARC** is the International Agency for Research on Cancer, a scientific group that classifies chemicals according to their cancer-causing potential.

**IRIS** is the Integrated Risk Information System database of the federal EPA.

A **miscible** substance is a liquid or gas that will evenly dissolve in another.

mg/m<sup>3</sup> means milligrams of a chemical in a cubic meter of air. It is a measure of concentration (weight/volume).

A **mutagen** is a substance that causes mutations. A **mutation** is a change in the genetic material in a body cell. Mutations can lead to birth defects, miscarriages, or cancer.

**NAERG** is the North American Emergency Response Guidebook. It was jointly developed by Transport Canada, the United States Department of Transportation and the Secretariat of Communications and Transportation of Mexico. It is a guide for first responders to quickly identify the specific or generic hazards of material involved in a transportation incident, and to protect themselves and the general public during the initial response phase of the incident.

**NFPA** is the National Fire Protection Association. It classifies substances according to their fire and explosion hazard.

**NIOSH** is the National Institute for Occupational Safety and Health. It tests equipment, evaluates and approves respirators, conducts studies of workplace hazards, and proposes standards to OSHA.

**NTP** is the National Toxicology Program which tests chemicals and reviews evidence for cancer.

**OSHA** is the Occupational Safety and Health Administration, which adopts and enforces health and safety standards.

**PEL** is the Permissible Exposure Limit which is enforceable by the Occupational Safety and Health Administration.

**PIH** is a DOT designation for chemicals which are Poison Inhalation Hazards.

**ppm** means parts of a substance per million parts of air. It is a measure of concentration by volume in air.

A **reactive** substance is a solid, liquid or gas that releases energy under certain conditions.

**STEL** is a Short Term Exposure Limit which is usually a 15-minute exposure that should not be exceeded at any time during a work day.

A **teratogen** is a substance that causes birth defects by damaging the fetus.

**TLV** is the Threshold Limit Value, the workplace exposure limit recommended by ACGIH.

The **vapor pressure** is a measure of how readily a liquid or a solid mixes with air at its surface. A higher vapor pressure indicates a higher concentration of the substance in air and therefore increases the likelihood of breathing it in.

## FIRE HAZARDS

- Use dry chemical, CO<sub>2</sub>, water spray, or foam extinguishers.
- POISONOUS GASES ARE PRODUCED IN FIRE, including Fluoride and Nitrogen Oxides.
- If employees are expected to fight fires, they must be trained and equipped as stated in OSHA 1910.156.

## SPILLS AND EMERGENCIES

If Cyanuric Fluoride is spilled or leaked, take the following steps:

- Evacuate persons not wearing protective equipment from area of spill or leak until clean-up is complete.
- Remove all ignition sources.
- Absorb liquids in vermiculite, dry sand, earth, or a similar material and deposit in sealed containers.
- Ventilate and wash area after clean-up is complete.
- It may be necessary to contain and dispose of Cyanuric Fluoride as a HAZARDOUS WASTE. Contact your state Department of Environmental Protection (DEP) or your regional office of the federal Environmental Protection Agency (EPA) for specific recommendations.
- If employees are required to clean-up spills, they must be properly trained and equipped. OSHA 1910.120(q) may be applicable.

## HANDLING AND STORAGE

- Prior to working with Cyanuric Fluoride you should be trained on its proper handling and storage.
- Cyanuric Fluoride is not compatible with OXIDIZING AGENTS (such as PERCHLORATES, PEROXIDES, PERMANGANATES, CHLORATES, NITRATES. CHLORINE, BROMINE and FLUORINE); STRONG BASES (such as SODIUM HYDROXIDE and POTASSIUM HYDROXIDE); and ALCOHOLS.
- Store in tightly closed containers in a cool, well-ventilated area away from WATER and MOISTURE as Cvanuric Fluoride may decompose.
- Sources of ignition, such as smoking and open flames, are prohibited where Cyanuric Fluoride is used, handled, or stored in a manner that could create a potential fire or explosion hazard.

## **Eve Contact**

Immediately flush with large amounts of water for at least 15 minutes, occasionally lifting upper and lower lids. Seek medical attention immediately.

### **Skin Contact**

Remove contaminated clothing. Wash contaminated skin with soap and water.

## **Breathing**

- Remove the person from exposure.
- Begin rescue breathing (using universal precautions) if breathing has stopped and CPR if heart action has stopped.
- Transfer promptly to a medical facility.
