Background

The New Jersey State Office of Rural Health (NJSORH), as part of its on-going effort to gain additional insight into health issues of residents living in rural areas of the state; sought feedback on their perceptions regarding the health and safety surrounding rural injuries to youth under the age of 19. A series of questions were developed focusing on four areas of interest - All Terrain Vehicles, Traumatic Brain Injury, Motor Vehicle Crashes and Workplace Injuries.

The NJSORH determined that one way to reach some of the target population, and to get feedback from several rural areas of the state was to include these questions as part of the existing five county Rural Health Focus Group Project (Atlantic, Burlington, Cape May, Cumberland and Ocean Counties). Although, the participants were not screened for having an interest, knowledge or experiences with rural injuries to youth, the NJSORH felt that gaining overall perceptions surrounding the subject from an interested, health care conscious group of New Jersey rural residents was viable.

The Rural Health Focus Group Project had 81 total participants (over a five county area). All participants were asked to complete the Rural Injury Questionnaire which some did not fully complete. In three of the five focus groups the moderator was able to gather some limited verbal feedback from the participants that was generally reflective of the responses supplied on the questionnaire (complied responses are included herein). Many of the participants did not have any youths in their household and therefore it should be noted that their answers might be reflective of their current life situation.

Summary - New Jersey Rural Injury Questionnaire

The New Jersey Rural Injury Questionnaire focused on four areas of interest:

- All Terrain Vehicles (ATV)
- Traumatic Brain Injury
- Motor Vehicle Crashes
- Workplace Injuries

All Terrain Vehicles

Based on the responses to the questionnaire, 59 of the participants (81 total) indicated that *few* or *none* of the young people (19 and younger) they know ride ATVs. Additionally, 42 responded saying *few* or *none* of those riding ATVs wear helmets. These responses align with the verbal feedback received from the participants. Although the majority did not know a significant number of ATV riders, participants were very frustrated regarding the lack of enforcement of the regulations for those youths that are riding ATVs. Many thought the police ignored riders who rode on streets, riders without helmets and underage riders. This feedback was especially evident in Cape May County and Cumberland County. Steven from Cape May County said:

Concerning ATVs, over the years I called the mayor's office and the state police and they may not have a legal place to drive them but they still drive them on the back streets...These people ride them down the street. No license, no insurance. And worse than that, no helmet and the police will not respond most of the time.

Bernard, another Cape May County resident added:

I used to be a public defender in the county and the police actually refused to follow an ATV. We have a problem at the airport with ATVs running up and down the runway. I looked out my window one day, I live on Washington Avenue, which is the main drag in town, there are kids doing wheelies down the middle of the street. It has gotten do bad that I've actually seen mothers and fathers teaching their kids how to ride illegally. I mean we're talking about six or eight-year old kids riding.

Otelia, a Cumberland County resident said:

And they're riding them on the road. They don't have insurance. They're not wearing their helmets. And it's really sad.

Cheryl, from Cumberland County described a scenario near her home:

Across the street from our house, that's where they ride in the bushes. Years ago, the cops would chase them and give them tickets, and I see them take the bikes from them and everything. But no, last week or the week before, the cop was standing there in his field, and he was watching them...Now they let them do it.

Traumatic Brain Injury

The overwhelming majority of participants would seek medical attention for bumps on the head with loss of consciousness, bleeding or nausea. The area where there was some dissension, was the topic of bumps on the head with no cut or bleeding; no loss of consciousness. Twenty-eight participants indicated they would not seek medical attention for this kind of injury. Some of the reasons the participants gave for not seeking attention include:

• Prior personal experience

- Because I would have to go to the emergency room and pay out of pocket and wait
- First aid training
- Not every bump will require a doctor's attention
- I would be in the doctor's office or emergency room all day everyday
- Went to Mexico and did not seek medical attention
- · Could not afford it
- Lack of coverage

Motor Vehicle Crashes (this section was not included on the questionnaire for Ocean County participants)

Forty of the participants (of 61 total participants) indicated that they *Strongly Agree* or *Agree* with the statement '*Do you feel Motor Vehicle Crashes are a problem among young people (19 and younger) in your community.'* When asked about death and severe injury to youth resulting from motor vehicle crashes, 21 participants responded that they knew someone that had been severely injured and 17 participants knew someone who had been killed.

On the subject of cell phones and texting while driving, 55 responded that *All* or *Most* young people talk on a cell phone while driving, while 50 participants indicated that this was a problem among young drivers in their community. Surprisingly, although most of the participants felt that youths were using cell phones while driving, the majority of participants felt that most youths used seat belts as driver, but used them less when riding as a passenger.

Workplace Injuries

Workplace injuries did not appear to be a problem as the majority of participants (64), responded *No* or *Don't Know* when asked 'Do you know of any 14-19 year old young people who were injured at work?' This could be a result of the lack of job opportunities for youth as expressed by several participants. The 12 respondents who said they did know someone who was injured, only one indicated they sought out medical attention for that injury.
