GENERAL DESCRIPTION

Under the general supervision of the Executive Director of Special Child Health Services, the Research Scientist 1 will independently initiate and coordinate research and management of the Early Identification and Monitoring (EIM) Program. Develops policy guidelines, administrative procedures, and regulations regarding the program. EIM collects and analyzes data from the Birth Defects and Autism Registry, the Hearing Registry, and the Critical Congenital Heart Defect program. This position works closely with the CDC and serves as the principal investigator on a CDC Birth Defects Prevention Surveillance Grant. The Research Scientist 1 will supervise staff (clinical and non-clinical) who collect data from hospitals and other health care providers under public surveillance laws to ensure that children with mandated conditions are registered and referred for case management services. This position will also work with other programs to create Data Use Agreements (DUA). Additionally, this position will need the skills to merge and analyze data, create public facing reports, and participate in research. As an example, the current research efforts include examining the etiology and relationship of autism and birth defects, blood-lead levels, hearing deficits, and pediatric cancers. The Research Scientist 1 will also need to develop and maintain effective and balanced working relationships with state, federal, academic, and other stakeholders to discuss and resolve issues of regarding the collection, use, and reporting of data to the registries. This position will also review proposed draft regulatory changes for fiscal or programmatic impact and make recommendations regarding the development and revision of agency policies based on changes to state and federal laws and regulations.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college or university with a Master's degree in a discipline appropriate to the position.

EXPERIENCE: Four (4) years of full-time experience in a field appropriate to the position.

NOTE: A Doctorate in a discipline appropriate to the position may be substituted for two (2) years of experience indicated above.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
