This position will have the responsibility to develop and review medication policies and procedures at the State Psychiatric Hospitals. In addition, this incumbent will provide oversight for the data reporting on poly-pharmacy, antibiotic stewardship and other pharmacy related issues within the State Hospital System.</p>
