GENERAL DESCRIPTION

Under supervision of a Crew Supervisor at Trenton Psychiatric Hospital, does varied types of plumbing work involved in the installation, repair, and maintenance of plumbing and steam fitting fixtures, fittings, and systems; does other related duties as required.

NOTE: This position is covered by the Centers for Medicare and Medicaid Services (CMS) Rule and Executive Order 283, requiring all employees to be fully vaccinated. To comply with that requirement, employees must provide proof of vaccination status. Please do not submit proof of vaccination at this time; instructions will be provided if an offer of employment results from this NOV.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EXPERIENCE: Three (3) years of broad experience in work involving the installation, inspection, repair, and maintenance of plumbing and steamfitting fixtures, fittings appliances, machinery, and plumbing systems.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
