GENERAL DESCRIPTION				
Under the supervision of the Supervisor Of Inspections, the Supervising Health Care Evaluator is responsible for assisting with the training of all Health Facilities Survey & Field Operations professionals as well as providers, consumers, and patients/residents. Develops and implements a standardized orientation program for newly employed or reassigned surveyors. Supervises all new surveyors until the completion of orientation. Utilizes & maintains a federal training database to ensure that employees are nominated to appropriate federal courses and that their status is accurately tracked on an ongoing basis. Supervises the preparation of travel requests for employees attending Federal Training. Identifies, provides and arranges for development programs for all staff on a general and individualized basis. Participates in the budget development and review process to facilitate the allocation of training resources. Provides training programs for surveyors, providers, consumers, and residents. Functions as back-up to RAI Coordinator and the Training Coordinator.

Education: Graduation from an accredited college or university with a Bachelor's degree.				
Experience: Four (4) years of experience in a health care plan, facility or organization as a registered nurse, nutritionist, occupatinal therapist, registered pharmacist, registered physical therapist, recreational therapist, social worker, or speech language pathologist, which shall have included two (2) years in a municipal, county, state or federal agency surveying, evaluating, or investigating health care plans, organizations or facilities for compliance with state and/or federal laws and regulations related to health care.
