Utilizes & maintains a federal training database to ensure that employees are nominated to appropriate federal courses and that their status is accurately tracked on an ongoing basis. Supervises the preparation of travel requests for employees attending Federal Training. Identifies, provides and arranges for development programs for all staff on a general and individualized basis. Participates in the budget development and review process to facilitate the allocation of training resources. Provides training programs for surveyors, providers, consumers, and residents. Functions as back-up to RAI Coordinator and the Training Coordinator.
