GENERAL DESCRIPTION

Under the direction of a Supervisor of Inspections in the Long Term Care Complaint Program, is responsible for exercising general direction over a team of professionals

Surveys a specified group of health care facilities to evaluate compliance with Federal Medicare/Medicaid certifications and state licensure laws.

Assures investigations/surveys are completed within mandated time frames, adheres to federal/state guidelines for conducting investigations and assures the validity/accuracy of the inspection process.

Assists with the actual survey and provides leadership, supervision and coordination to a team of evaluators, with additional support specialists when needed.

Utilizes the Aspen Complaints Tracking System within the ASPEN Systems to input complaint data and gather data to generate and access information.

Preferred Experience: Survey experience in healthcare facilities and prior successful completion of the Surveyor Minimum Qualifications Test (SMQT).

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

Education: Graduation from an accredited college or university with a Bachelor's Degree.

Experience: Four (4) years of experience in a health care plan, facility or organization as a registered nurse, nutritionist, occupation therapist, registered pharmacist, registered physical therapist, recreational therapist, social worker, or speech language pathologist, which shall have included two (2) years in a municipal, county, state or federal agency surveying, evaluating, or investigating health care plans, organizations or facilities for compliance with state and/or federal laws and regulations related to health care.

Note: Applicants who have graduated from an accredited school of nursing or possess an Associate's Degree in Nursing may substitute two (2) years of additional experience on a year-for-year basis for the required Bachelor's Degree.

Note: Long-term care positions require the successful completion of the Basic Surveyor Training and passing the Surveyor Minimum Qualifying Test.

License: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.
