<p><b>CERTIFICATION</b> Possession of a valid Certificate to Practice Psychiatry issued by the American Board of Psychiatry and Neurology. <b>EXPERIENCE:</b> Three (3) years of clinical experience in the practice of Psychiatry subsequent to Board Certification. <b>NOTE:</b> A sub-speciality board certification in Addictions, Geriatrics, or Forensics may be substituted for one (1) year of experience. <b>NOTE:</b> A sub-specialty board certification in Child or Adolescent may be substituted for two (2) years of experience. <b>LICENSURE:</b> Possession of an Unrestricted License to practice medicine in the State of New Jersey. Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.</p>
