GENERAL DESCRIPTION

This position reports to the Director of Health Care Quality Assessment (HCQA) and is responsible for the following activities:

Design and conduct research on quality of stroke care in New Jersey using various complex data sources. The individual will develop research proposals with sound research methodology and statistical techniques. The individual will analyze large complex data such as the New Jersey Acute Stroke Registry (NJASR) data, Joint Commission stroke care measure data, and Uniform Billing data using statistical software such as SAS to assess hospital performance in stroke care in New Jersey. The individual will prepare scientifically sound and accurate report on findings, conclusions and recommendations regarding quality of stroke care in New Jersey.

Design and implement research in quality of cardiac care in New Jersey. The individual will perform data linkage and analysis of large and complex Cardiac Surgery and Cardiac Catheterization Registries using statistical software such as SAS to assess the quality of cardiac care in New Jersey. The individual will prepare scientifically sound and accurate report on findings, conclusions and recommendations regarding quality of cardiac care in New Jersey.

Utilize data visualization to identify patterns, trends and outliers in large complex data sets. This individual shall have basic knowledge of data visualization. Knowledge and experience of data visualization tools are preferred.

Conduct other health care services research as needed.

This position may be eligible to participate in the Department's pilot telework program, which offers eligible employees the opportunity to work remotely for up to two (2) days per week, as approved by management.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college or university with a Master's degree in a discipline appropriate to the position.

EXPERIENCE: Three (3) years of full-time experience in a field appropriate to the position.

NOTE: A Doctorate in a discipline appropriate to the position may be substituted for two (2) years of experience indicated above.

LICENSE: Appointees will be required to possess a valid driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essentials duties of the position.
