GENERAL DESCRIPTION			
<p>Under the direction of the Program Manager, coordinates and supervises the day to day activities of the Complaint Surveyors assigned. Reviews inspection reports for accuracy, validity and completeness. Responsible for evaluation of performance and PAR reviews for assigned staff. Responsible for evaluation of facilities for compliance and recommend adverse action when needed. Attend Informal Dispute Resolutions (IDR) with/for surveyors assigned. Represent the Department as needed at meetings and hearings. Collects and maintains statistical information for the Program Manager to be used for budget purposes. Triage Complaints and Reportable Events based on the State Operations Manual and Federal state performance standards and policies. On a rotating basis takes off-hour emergency calls regarding complaints and reportable events. Assist the Program Manager with other operational responsibilities to facilitate functioning of the unit.</p> <p>Appointees will be required to successfully complete the Basic Long Term Care Surveyor Training and pass the Surveyor Minimum Qualifying Test. Training will be provided at the onset of employment.</p> <p>Appointees will be required to possess a driver's license valid in NJ.</p> <p>NOTE: This position may be eligible to participate in the Department's pilot telework program, which offers eligible employees the opportunity to work remotely for up to two (2) days per week, as approved by management.</p>

<p>EDUCATION: Graduation from an accredited college with a Bachelor's degree.</p> <p>EXPERIENCE: Four (4) years of experience in a health facilities inspection program, one (1) year of which shall have been in a supervisory capacity.</p> <p>NOTE: Applicants who do not possess the required education may substitute experience as indicated on a year-for-year basis.</p> <p>NOTE: Applicants who do not possess the required Bachelor's degree but have graduated from an accredited school of nursing and possess a license as a Registered Professional Nurse (RN) may substitute two (2) years additional years of experience as indicated above for the Bachelor's degree</p>

PHEL Candidates:

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

Direct Client Care:

If you are a candidate for a position that involves direct client care in one of the State facilities/programs, you may be subject to pre- and/or post-employment drug testing/screening. The cost of any pre-employment testing will be at the candidate's expense. Candidates with a positive drug test result, or those who refuse to be tested and/or cooperate with the testing requirement, will not be hired.

**New Jersey
First Act:**

In accordance with N.J.S.A. 52:14-7, the "New Jersey First Act", all employees must reside in the State of New Jersey, unless exempted under the law. If you do not live in New Jersey, you have one year after you begin employment to relocate your residence to New Jersey.

Resume Note:

Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in your ineligibility.

Authorization to Work:

Selected candidates must be authorized to work in the United States according to the Department of Homeland Security, United States Citizenship and Immigration Services Regulations. The State of New Jersey does **not** provide sponsorships for citizenships to the United States.

Note: Newly hired employees must agree to a thorough background check that will include fingerprinting.
