GENERAL DESCRIPTION			
Under the direction of a supervisory officer in a state or local institution or agency, assists in the design, overseeing, and implementation of a program of music therapy; does related work as required. This position is covered by the Centers for Medicare and Medicaid Services (CMS) Rule and Executive Order 283, requiring all employees to be fully vaccinated. To comply with that requirement, employees must provide proof of vaccination status. EDUCATION: Graduation from an accredited college or university with a Bachelor's degree with a major course of study in music, music therapy or music education. EXPERIENCE: One (1) year of professional experience in a Music Therapy Program. NOTE: A Master's degree in music therapy or creative music therapy or music education with a specialization in music therapy may be substituted for one (1) year of experience. LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
