GENERAL DESCRIPTION

Under direction of the Chief Nursing Officer in a Psychiatric Hospitals, as a part of the treatment team performs clinical nursing; provides clinical consultations, and participates in the education of nursing staff; does other related work.

This position is covered by the Centers for Medicare and Medicaid Services (CMS) Rule and Executive Order 283, requiring all employees to be fully vaccinated. To comply with that requirement, applicants must provide proof of vaccination status. Please do not submit proof of vaccination at this time; instructions will be provided if an offer of employment results from this Notice of Vacancy.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college or university with a Master's degree in Psychiatric/Mental Health or Geriatric Nursing or graduation from an accredited college or university with a Bachelor's degree in Nursing supplemented by a Master's degree in Nursing, Psychology, Social Work, Counseling and Guidance, Human Development, or related field.

EXPERIENCE: One (1) year of experience in the treatment of psychiatric or geriatric patients.

CERTIFICATION: Appointee must possess or be eligible for certification from the A.N.A. or other nationally recognized certifying agency as a Clinical Specialist in Psychiatric/Mental Health Nursing.

NOTE: Applicants must be a Registered Professional Nurse, currently licensed in the State of New Jersey.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
