GENERAL DESCRIPTION			
<p>Under the limited supervision of a Social Work Supervisor or other supervisory official at the Trenton Psychiatric Hospital, performs varied types of tasks in aiding children and adults to make satisfactory social and emotional adjustments; does other related duties as required.</p> <p>NOTE: This position is covered by the Centers for Medicare and Medicaid Services (CMS) Rule and Executive Order 283, requiring all employees to be fully vaccinated. To comply with that requirement, employees must provide proof of vaccination status. Please do not submit proof of vaccination at this time; instructions will be provided if an offer of employment results from this NOV.</p>			
REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)			
<p>EDUCATION: Graduation from an accredited college or university with a Master's degree in Social Work.</p> <p>EXPERIENCE: One (1) year of experience in social case work, involving responsibility for gathering and analyzing social information from clients, the determination of their needs, and the planning and administration of treatment plans geared toward the needs of the individual clients.</p> <p>LICENSE: Registration as a Licensed Social Worker (LSW) in the State of New Jersey. Applicants may be in the process as long as there is evidence of a passing score on licensure exam and that the application has been submitted.</p> <p>Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.</p>
