GENERAL DESCRIPTION

Under the general supervision of the Executive Director of Special Child Health and Early Intervention Services, this position has primary responsibility for the oversite of the statewide implementation of the New Jersey Early Intervention System (NJEIS), including the administration of the federal grant under Part C of the Individuals with Disabilities Education Act (IDEA). The NJEIS provides services to about 27,400 New Jersey children and their families annually with a budget of \$170+ million comprised of federal and state funds, including Medicaid reimbursement and family cost participation. This position directs all state-wide system components to ensure that all eligible NJ children and their families receive referral, evaluation, determination of eligibility, and development and implementation of Individualized Family Service Plans (IFSP) including the provision of early intervention services. This position supervises staff engaged in conducting a research program or project; coordinates the research program with other programs within and outside of the agency as appropriate; Also responsible to assist with promulgation of rules and regulations; implement a general supervision accountability system which includes development of procedures to ensure policies are implemented; monitoring of early intervention provider agencies (REICs, SCUs, EIPs) compliance and results performance; identification of noncompliance & areas for improvement and verification of corrective actions and provider agency improvements.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

Education: A Doctorate from an accedited college or university in a discipline appropriate to the position.

Experience: Four (4) years of experience in an area appropriate to the position.

Note: A Master's degree in a discipline appropriate to the position plus an additional two (2) years of experience as specified above may be substituted for the Doctorate.

License: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather then employee mobility is necessary to perform the essential duties of the position.
