Under direction of Manager or Supervisory official, this position is responsible for working with Health Monitoring to ensure quality assurance controls and protocols with regard to the collection and monitoring of syndromic surveillance data and maintain standards to validate data. Serves as administrator of emergency department (ED) data and user access as part of the National Syndromic Surveillance Program and related health information initiatives. Serves as the epidemiologist liaison between Health Monitoring (the vendor for EpiCenter) and the Department programs using the data and analyses. Provides subject matter expertise in support of surveillance and informatics research activities and provides technical support to NJDOH staff. Supports surveillance and research activities with EpiCenter, NJ's syndromic surveillance system and provides technical assistance in the development of analytic protocols for syndromic surveillance data.

EDUCATION: Graduation from an accredited college or university with a Master's degree in a discipline appropriate to the position. EXPERIENCE: Three (3) years of full-time experience in a field appropriate to the position.
