Collects COVID-19 and other infectious disease investigation and contact tracing data, enters it into appropriate data management system, and ensures data quality. Confers with physicians, patients, disease contacts, social workers, and others when preparing case and contact investigations, summary reports, and other data supporting diagnostic or reported vital statistics information. Conducts investigation of reports with incomplete reporting techniques, and maintains liaison with healthcare facilities, providers, schools, local health departments, and other cooperating agencies. Gives talks to interested groups and/or instructions to improve reporting techniques, accuracy of reports, and to increase knowledge and compliance with COVID-19 investigation and contact tracing. In conjunction with local health department staff, visits patients or contacts at home, at work, at health care facilities, or other locations to implement contact tracing and public health control actions.

EXPERIENCE: One (1) year of experience in a health or social service related program which shall have included responsibilities for interviewing, investigating, and/or conducting public health care surveys or patient care services.
