### **Contract Reporting Requirements**

- Attendance Reporting
- □ Contract expenditure reports:
  - Interim (quarterly)
  - Fiscal-year-end
  - Final (at contract termination and within a maximum of 120 days following termination)
- Annual audit
- FY'12 Contract Renewals



#### **Contract Close-Out Process**

- DDD reconciles amount of funding paid to a Provider Agency during the contract term against the final Report of Expenditures (ROE).
- DHS determines that all applicable administrative actions and all required work of the contract have been completed by the Department and the Provider Agency.
- ☐ Final ROE (FROE) is due within 120 days of contract term end.

## Medicaid Program Changes, 2011

- Mandatory enrollment into an HMO with August 1, 2011 effective dates
  - ABD without Medicare
  - All DYFS children
  - All clients with DDD, including those on CCW except duals
  - Clients who currently have exemptions
  - Clients already enrolled in or covered by a commercial
  - Pharmacy lock-in clients
  - Breast and Cervical Cancer program clients



## Medicaid Program Changes, 2011

- Mandatory enrollment into an HMO, Phase 2 -Fall 2011 effective date
  - Dually eligible clients
  - All other Waiver clients (ACCAP, CRPD, GO and TBI Waivers)



## Services in Managed Care on July 1, 2011

- Home health care for HMO members
- Pharmacy for all HMO members
- Personal Care Assistant services except Personal Preference Program
- Adult and pediatric medical day care
- PT, OT and Speech therapies

## Services Remaining in Medicaid Fee-for-Service

- Nursing facility care beyond 30 days
- Personal Preference Program (selfdirected PCA services)
- Transportation through LogistiCare except for emergency ground transportation, which is covered by HMO
- Methadone and its administration
- Institutional services

#### **HIPAA** Guidance

- A covered entity may disclose protected health info to another covered entity if:
- Either entity has/had a relationship with a client and the information pertains to that relationship; and
- The disclosure is for quality-related health care operations activity.



#### **More HIPAA Guidance**

- A covered entity may disclose protected health information to a health care provider for:
- Treatment activities;
- Payment activities; and
- Health care operations.
