

# Realigning, Streamlining & Restructuring of DD Services for Children

- Consistent with the vision that people with developmental disabilities – including children – should not be "carved out" of systems of care or generic supports available to other children and their families
- Builds on the work that has already started through the DDD-DCF Workgroup
- Commitment from both Departments to make the transition as seamless as possible

# Realigning, Streamlining & Restructuring of DD Services for Children

- Timeline for Restructuring
  - Now thru June 30, 2013 Collaboration among Departments and with stakeholders to facilitate transition
  - July 1, 2012 DDD's Children and Youth DCF Division of Child Integrated System of Care Services (DCISCS)
    - DDD will continue to assist with eligibility determinations until January 1, 2013.
  - January 1, 2013 DDD Family Support Services DCISCS
- Pilot Programs in the Comp. Waiver (pending approval)
  - For Children with Dual Diagnosis
  - For Children with Pervasive Developmental Disorder (PDD)

- □ Transition Age 16-21
  - Time for a focus on Transition Planning for the individual
    - Major information sharing between DDD, DCISCS and family
    - Coordinated service effort to ensure seamless transition
  - Interplay with the Comprehensive Waiver
    - DDD eligibility process beginning at age 16

## Major Increases / Decreases - DDD

#### FY12/FY13 Non-Olmstead Community Placements

- Grant-in-Aid (State) \$29.3M increase (Page 108 of FY13 Budget Summary)
  - □ This is a combination of \$24.7M (for new FY13 placements) plus \$4.6M (for annualization of FY12 placements)
- Federal \$9.3M increase
  - □ This is a combination of \$7.7M (for new FY13 placements) plus \$1.6M (for annualization of FY12 placements)
- TOTAL INCREASE (Gross) \$38.6M

## Major Increases / Decreases - DDD

#### This overall Community increase is budgeted for:

- 1. Approximately 600 new FY13 consumers
- 2. Approximately 600 consumers placed in FY12

#### Funding will address the following areas:

- <u>CEPP</u> Conditional Extension Pending Placement
- □ CSWL Community Services Waiting List
- □ Emergencies Residential, Day, 1-to-1s, etc.
- □ Age-Out Day Programs
- Age-Out Residential



## Major Increases / Decreases - DDD

#### FY12/FY13 Olmstead Community Placements

- Grant-in-Aid (State) \$9.8M increase (Page 108 of FY13 Budget Summary
- Federal \$8.3M increase
- TOTAL OLMSTEAD (Gross) \$18.1M
  - This increase will provide funding for:
    - 175 Community Placements (FY13)
    - 125 Community Placements (FY12 Annualized)

## Major Increases / Decreases - DDD

## Additional Funding to DDD for ALL Community Placements:

\*\*\* \$56.7 million \*\*\*

#### **Increased commitment to:**

- Tie services to Medicaid eligibility;
- Ensure that all consumers maintain Medicaid eligibility;
- Focus on the provision of core mission services; and
- Ensure non-duplication of services that can be accessed through Medicaid or other sources.



### Transfer of Funds – DDD to DCF

In conjunction with the proposed realignment of services for children to DCISCS, total funding reflected in the FY13 Budget is \$34.7M

While these funding amounts have been moved in the proposed FY13 Budget, they should not be considered absolute or final. Due to the complexity of the pending restructuring, the Governor's Budget will contain a budget provision that will allow for transfers of funds between the two Departments (subject to Treasury Approval). A reconciliation of funding will continuously occur throughout the realignment to ensure that the funds are properly allocated in line with the services being delivered.

<u>This is not a cost saving initiative</u> – neither Department will suffer a net loss of funding as a result of the transfer.

# Children to DCF – Provider/Contract Implications

- DCF will assume responsibility for children in residential placements effective July 1, 2012. DCF will establish a contractual relationship with providers effective July 1, 2012 to ensure their payments for services continues during the transition.
- Funding for family support will remain at DDD in existing contracts - until December 31, 2012. DCF will assume responsibility for all funding associated with family support for children effective January 1, 2013.



  - Incidents
  - Surveys
  - Infrastructure
  - Economics of the surrounding communities
- Visit all seven Developmental Centers and community settings (group homes, apartments, etc.)
- Meet with Stakeholders through the public meeting process
- Review all information and provide a decision on the future of developmental centers in New Jersey within 90 to 180 days of organizing (February 13, 2012)
