- I. Administrative Issues/ Correspondence/ Minutes
  - A. Minutes from the April Meeting were reviewed and approved as written
  - B. Partnership for a Drug Free NJ is holding forums across the state for physicians; distributed a flyer for June 11, 2014
- II. Children's System of Care update Elizabeth Manley
  - A. Distributed updated Strategic Plan for 2014-2016
    - 1. Provide data dashboard to Commissioner and Children's Inter Agency Coordinating Council (CIACC)
    - 2. Continue work with youth with developmental disabilities and youth with substance use disorders
    - 3. Partnering with agencies (schools) regarding CSOC
  - B. Rolling out Comprehensive Medicaid Waiver Components for CSOC
    - 1. Dually Diagnosis and youth with autism
    - 2. Provide services that weren't previously available
    - 3. Provide Applied Behavioral "Analysis (ABA), an EBP, for youth with autism
    - 4. Providers are still being notified that they are in the new provider pool
    - 5. Youth are in care management organizations
  - C. Rolling out with DMHAS the behavioral health home in Bergen and Mercer
  - D. Busiest month in March we've ever had with a lot of calls for families who are newly enrolling
  - E. Rolled out six detoxification beds at Lighthouse at Mays Landing for Super Storm Sandy beds
    - 1. Currently underutilized so may expand eligibility to age 21

- F. IOP programs aren't as busy as expected
- G. Residential beds have large uptick and are being used
- H. Comments/Questions
  - 1. Q. Ellen In Bergen County there is no uptick in residential. A. We have approximately 238 beds and around 200 are full so we are interested in how they are being filled
  - 2. Q. Marie In your Strategic Plan what are your plans for emerging adults with Mental Health and SUD? A. Our biggest challenge is engagement. We do have an Office of Adolescent Services (16 21) and they have a different spectrum of services. We work with them on these services.
  - 3. Q. Harry– Are ABA services in home? A. They're intensive home based services. We are looking for tight planning with schools on this
  - 4. Q. Joanne What about adolescent suicide? A. Teen Suicide Prevention is in Family and Community Partnerships Division. It is a big issue for the Commissioner. We can get more information to you.
  - 5. Q. Joe How many "age out" from your system to the adult system? A. We don't collect data that way so I can't drill down on that. In our 2015 goals we're trying to figure out how to get that.
  - 6. Q. Joe Do kids who age out remain on SSI/Disability? A. Its information we don't have but want to get.
  - 7. Q. Suzanne Are the pre-authorizations you're doing now new in your system or already existing for Mental Health? A. Most come in before they are 18 to our system.

# III. Mental Health Block Grant 5% set aside – Donna Migliorino

- A. In the application last year we scrambled to develop responses to newly mandated 5% and 3% set asides which delayed us in reporting out
- B. Once final federal budget was approved it excluded those set asides and changed it to 5% for first episode psychosis
- C. Our modification to the plan is due May 29, 2014
- D. The federal government is recommending an evidence based program (EBP) and we don't have to go with that one, however we've decided to move forward with it because of the deadline
- E. We're working with CSOC.
- F. \$648,121 is the 5% set-aside
- G. Recovery After An Initial Schizophrenic Episode is the EBP
  - 1. We're looking for technical assistance and SAMHSA will be doing a webinar at some point
  - 2. In 2011 the National Institute of Health funded St. Clare's to do this program
  - 3. We can't throw this together in two weeks with a lot of specificity so we want to submit something more globally
- H. Ouestions/Answers
  - 1. C. Marie Involve consumers in this process to obtain what they thought helped.
  - 2. Q. Chris Is there any flexibility in the May 29, 2014 deadline? A. I don't know. A lot of this may be reactionary to natural events we don't know how long this 5% will even last.
  - 3. Q. Mike What about under age 10? First episode does happen under age 10.

Will they be able to get services? A. – We could raise that issue when we meet. St. Clare's is treating ages 15-40.

- 4. C- Winfred NIH does studies with data you may be able to use
- IV. Mental Health Association of New Jersey Overview of Recovery and Rebuilding Services Anne Lopez and Stephanie Mulfinger
  - A. Presented a power point and distributed materials
    - 1. A statewide call center (NJ Mental Health Cares) 866-202-4357
    - 2. Open 8:00 a.m. to midnight
    - 3. Offers a follow up call to all callers
    - 4. Not a crisis service but do have an on-call person to address urgent crisis after hour calls if necessary
    - 5. also has a peer recovery warm line
    - 6. In SSBG we are the gateway to services
    - 7. Also have ability to text for help too (started this in February and is about 30 40% of volume.)
    - 8. If someone is from another state we are able to connect them to resources like us in their State
    - 9. Peer Outreach Support Team in Atlantic and Ocean
    - 10. Mental Health First Aid in Bergen, Hudson, Ocean and Middlesex
  - B. Comments/Questions
    - 1. Q. Patrick Who is giving the emotional support? A. We're trying to create more structure. It's been falling on Disaster Coordinators.
    - 2. C. Connie We can present on this next month because we just got a DCF Grant to go in the schools in the five southern counties and hired fifteen staff. Rutgers got the grant for the North.
    - 3. Q. Chris Define trained Mental Health Professional. A. 80% are Masters level and others are Bachelor's. We have a total staff of thirty-five people and all are supervised by either LPC or LCSW.
    - 4. C. Suzanne 211 is the Addiction Hotline of New Jersey and has trained counselors. It does screening for eligibility and warm handoff to a treatment agency.

- 1. Bylaws subcommittee met this morning and was well attended. Will meet again on June 11, 2014.
  - 1. Hope to have new bylaws for the group before the end of the summer that is complete.
- B. Olmstead Subcommittee Domenica Nicosia
  - 1. Post 7/08 CEPP's
    - a. As of December 2013 we're at 52% of non-legal being discharged within four months of designation
    - b. As of December 2013 we're at 15% of legal being discharged within designation
  - 2. Pre 7/08 CEPP
    - a. Most are legally involved or are refusing
    - b. Six at Ancora and two at Greystone Park Psychiatric Hospital, and none at

## Trenton Psychiatric Hospital

- 3. Placements (All discharges)
  - a. Private residence still most popular (213)
  - b. SH (79)
  - c. Group Home (69)
  - d. Correctional facility (40)
  - e. RHCF (26)
  - f. CEPP Placements/discharges
  - g. Private residence (111)
  - h. SH (65
  - i. Group Home (53)
  - j. RHCF (21)
  - k. Nursing facility (19)
- 4. Refusals
  - a. Pre 7/1/08 (8 total), 4 still refusing, and 3 are justice involved
  - b. Remaining refusals 47 total 478 on CEPP
- 5. Comments/Questions
  - a. Q. John What is "refusing to be discharged"? A. Some consumers have fears about leaving or will only agree to impossible places (like to their deceased relatives house)
  - b. C. Patrick In addictions once funding runs out they have to leave
  - c. Q. Chris Are those refusing all psychotic? A. No, some want to resolve legal issues or other items first.
  - d. Q. Robin The lawsuit is about to end. What's going to happen? Sounds like your numbers aren't good. A. The legal population is a lot different than non-legal population. Only about a third is left in the state hospital now.
