 - A. Updates to the Mental Health URS Tables beyond what was discussed at the meeting last month
 - a. 5% increase in the amount of educators who attended suicide training
 - b. Functional Family Therapy 379 receiving services
 - c. Multi Systems Family Therapy- 177 receiving services
 - d. Therapeutic Foster Care 853 receiving services
 - e. IMR 5855 receiving services
 - B. Consumer Perception of Mental Health Care

 - c. MOE for state expenditure on Mental Health Services was met at 462,681,392

E. Addiction data for SAPT Report

- a. Targets include:
 - i. Pregnant women/women with children-goal was to increase by 2% and we increased by 5%
 - ii. IVDU goal was to increase by 2% those who get medication assisted treatment (MAT); only increased it by 1%. There's still such a stigma around MAT in our system, and we are hopeful that Narcan may help to shift this.
 - iii. HIV area goal was to attain 30 sites for rapid testing and we didn't meet first year target but should meet second year target of 34 sites because we're at 31 sites as of October 2014
 - iv. Underage Drinking goal was to reduce drinking in past month for persons aged 12 20 and this target was achieved

- c. In depth technical assistance (IDTA) just heard that we were one of six states who received this award for In Depth Technical Assistance
