Notice of Availability of Grant Funds to Provide Supportive Housing Services for Individuals with Substance Use Disorders

**Take notice** that, in compliance with N.J.S.A. 52:14-34.4 and 34.6, the Division of Mental Health and Addiction Services (DMHAS) hereby announces the availability of the following grant program funds:

Name of Program: SUPERSTORM SANDY RECOVERY AND REBUILDING INITIATIVE FOR SUPPORTIVE HOUSING FOR INDIVIDUALS WITH A SUBSTANCE USE DISORDER

<u>Purpose:</u> The Division of Mental Health and Addiction Services seeks proposals to provide supportive housing for 141 adults diagnosed with substance use disorders who resided between October 28, 2012 to October 30, 2012 in one of the following counties: Atlantic, Bergen, Cape May, Cumberland, Hudson, Essex, Middlesex, Monmouth, Ocean and Union.

<u>Amount of funding available:</u> Funding of up to \$9,897,600 is available through this announcement to create housing opportunities for 141 individuals.

<u>Organizations that may apply</u>: In order to be eligible for consideration for this Request for Proposal, an applicant must be a fiscally viable corporation duly registered to conduct business within the State of New Jersey.

The applicant must demonstrate the ability to comply with all rules and regulations for any DMHAS program element of service proposed by the applicant.

The applicant must comply with the terms and conditions of the Department of Human Services' contracting rules and regulations as set forth in the DHS Standard Language Document, the <u>Contract Reimbursement Manual</u> (CRM), and the <u>Contract Policy and Information Manual</u> (CPIM).

Any fiscally viable corporation, as noted above, which meets the qualifications of the Department of Human Services' <u>Contract Policy and Information Manual</u>, N.J.A.C. 10:3, may apply.
