Recodification of N.J.A.C. 8:82 through 8:83E and 8:86 through 8:92

Take notice that, pursuant to the transfer of Division of Aging Services and its programs from the Department of Health to the Department of Human Services under P.L. 2012, c. 17, § 398 (N.J.S.A. 30:1A-14), the Department of Human Services, Division of Aging Services requested, and the Office of Administrative Law agreed to permit, the administrative recodification of the above-referenced rules of the Division from Title 8, Health, to Title 10, Human Services, of the New Jersey Administrative Code. These recodifications, along with attendant technical changes to the rule text concerning cross-references, agency names, addresses, etc., and the elimination of text rendered redundant or moot by the transfer of authority, are effective June 16, 2014, and shall be manifested in the New Jersey Administrative Code in the July 7, July 21, and August 4, 2014, Code updates. The table below sets forth the Title 8 chapters being recodified along with their chapter headings and new Title 10 codification. N.J.A.C. 8:85, Long-Term Care Services, will be recodified as N.J.A.C. 10:163 at a later date, following consultation between the Departments.
