NOTICE OF SCHOOL CLOSING

Star Career Academy

On November 15, 2016, the Star Career Academy (SCA) ceased to operate and closed its schools at the following locations:

Currently, the Center for Occupational Employment Information's Training Evaluation Unit (TEU) is in the process of obtaining information from the school as well as students enrolled at the time of the school's closure. Additional information can be found on the Star Career Academy's website at http://starcareer.edu.

The Star Career Academy has scheduled a webinar for December 13, 2017 at 11:00 EST which can be accessed at https://studentaid.ed.gov/sa/about/announcements/closed-school#star. The webinar will be recorded and transcribed, so if students are not able to attend, they can listen or read at a later time. While this is an understandably trying time for all students affected by this closure, the TEU is asking for your patience. It is imperative that you contact your lending institution to notify it of the school's closure.



Hundreds of current students at the time of its closing had completed sufficient hours and coursework to complete their programs and will be graduated. Any students who are eligible for graduation, will be contacted directly by a SCA representative to inform by telephone and confirm their mailing address to send transcripts.

Star Career Academy has contacted several educational institutions that have invited students to complete their studies at these other schools. Students requiring information on their certification exams can contact the National Certification for Competency Testing at (800) 875-4404, extension 3030.

The TEU is requesting that all students enrolled at the Star Career Academy on or about November 15, 2016, forward the following information as soon as possible:

- Name, address, phone number and email address;
- Copy of the signed Enrollment Agreement with the Star Career Academy;
- Receipts for any out-of-pocket tuition payments to the Star Career Academy;
- Cancelled checks payable to the Star Career Academy for tuition;
- Credit card receipts for tuition payments to the Star Career Academy;
- Copies of loan agreements/disbursements for student loans; and,
- Documentation of completed courses (i.e., transcripts, progress reports, course examinations, etc.).
