### **DGE Announces July 2016 Gaming Revenue Results**

#### **ATLANTIC CITY —**

Based upon filings with the Division of Gaming Enforcement, Casino Win for the month of July was \$257.9 million compared to \$245.0 million in July 2015, a 5.3% increase. Internet Gaming Win was \$17.4 million in July compared to \$12.5 million in the prior period, reflecting an increase of 38.6%. Total Gaming Win for the month was \$275.3 million compared to \$257.5 million in Total Gaming Win for July 2015, reflecting a 6.9% increase. Note that the weekend calendar for July 2016 compares favorably to July 2015.

For the year-to-date, Casino Win totaled \$1.41 billion through July 2016 compared to \$1.39 billion in the prior period, reflecting an increase of 1.5%. Internet Gaming Win was up 32.8% to \$112.2 million. Total Gaming Win was \$1.52 billion, up 3.2% for the first seven months of 2016.

For the month of July 2016, total gaming taxes were \$21.4 million. Total gaming taxes reflect 8% of taxable casino gross revenue and 15% of Internet gaming gross revenue. In addition, the casino industry incurred \$3.7 million in reinvestment obligations with the Casino Reinvestment Development Authority, which reflects 1.25% of casino gross revenue and 2.5% of Internet gaming gross revenue.
