New Jersey Guardsman earns U.S. citizenship

BAGRAM AIRFIELD, Afghanistan - When Cardon Edwards came to the United States with his mother from Jamaica, the 13-year-old couldn't imagine he would fight for the country he was heading to.

Seven years later, the now 20-year-old is doing much more than that. Not only is he a private first class in the U.S. Army, he now has a much greater title – American.

Private 1st Class Cardon Edwards joined 44 other U.S. Soldiers and Marines from 25 countries in a naturalization ceremony to become American citizens at Bagram Airfield Sept. 28.

"It's a relief, I'd be lying if I said it wasn't," Edwards said. "My parents are happy to see the steps I've taken and the road I've come down, in joining the Army and becoming a citizen."

His family knows what he's going through. His mother earned her U.S. citizenship two years ago. He couldn't go through the same process because he had already turned 18, he said.

The ceremony comes during Edwards' first deployment. The infantryman from the 2nd Battalion 113th Infantry Regiment of the New Jersey Army National Guard, is now deployed to Afghanistan as part of the Paktika Provincial Reconstruction Team.

The PRT's main job is to help bring the different levels of government and the province's 400,000 residents together. This way, their futures involve peaceful leadership and development, not insurgency under groups like the Taliban.

Edwards and the rest of his security team from the New Jersey Army National Guard help make sure the meetings that help move the governance process can happen safely for coalition members and Afghans.

"I have worked with Private 1st Class Edwards since August 2010 to train for this deployment and what I've seen is that though he's a

younger soldier, he has the maturity of a seasoned non-commissioned officer,” said 1st Lt. John Cossolini, 2-113 platoon leader. “He’s mentally strong and physically tough. He has unlimited potential and I see him becoming one of our steadfast NCOs very soon.”

Experience is a trait of many NCOs. Edwards said this deployment is helping him gain that, which is one of the reasons he joined the military.

“This deployment hasn’t been that bad, I’ve gotten to experience the different cultures and people, I like it so far,” he said.

Though there’s a significant difference between U.S. and Afghan cultures that this deployment is showing him, Edwards said he didn’t notice a huge difference between the

U.S. and Jamaica. He said he will take advantage of some of the differences he has noticed between where he was born and the new country he’s now a citizen of.

“There’s more opportunities in the U.S. of course, with better jobs, schools and universities,” he said. “When the deployment is over I’ll head back to school using the G.I. Bill to continue working on an associates in accounting. Then I’ll move on to a bachelor’s degree.”

His platoon leader had nothing but good things to say about one of his most junior soldiers, who was promoted to private first class just six months ago.

“He has always displayed the motivation and dedication of an infantryman, I could not ask for more from this young troop – he constantly gives 100

percent effort,” Cossolini said. “I have never seen his motivation, his trust in his fellow soldiers or his will to fight for his



Tuition waiver program celebrates 20-year anniversary

Program has been fundamental in enlistment and retention of NJ Guardsmen

The signing of the law that provided the New Jersey National Guard Tuition Program (NJNGTP) to its members recently reached its 20-year anniversary.

On Oct. 3, 1991, then Gov. Jim Florio signed into law a significant legislation, the New Jersey Tuition Program Bill (A-3222), during a ceremony held at the Lawrenceville Armory.

During this ceremony Florio made the following statement, "when a man or woman steps up to serve their country and their state, they stir our pride. The men and women who serve in the New Jersey National Guard know all about pride. It's part of why they serve. Today's bill signing ceremony is a reflection of that pride we have and this bill is a way of saying thanks. I'm pleased to sign it because it reflects my belief that education is just another word for opportunity."

The NJNGTP has long been a primary incentive for enlistment and retention for members of the New Jersey National Guard.

It has been provided through the generosity of the citizens of the state of New Jersey in grateful recognition for the sacrifices and contributions of its Citizen Soldiers and Airmen.

This benefit has given countless Soldiers and Airmen of the New Jersey National Guard the opportunity to better themselves, the New Jersey National Guard, and the communities they now serve.

Of important note are those individuals at the state schools and at the NJNG units who have worked hard to ensure the NJNGTP worked for the service members.

Some changes to the law have occurred through the years that have improved the program.

The NJNGTP now provides tuition free enrollments at any one of the 31 public colleges and universities in New Jersey, for up to 15 credits per semester all the way up to a graduate degree.

In addition, these benefits are extended to the child or surviving spouse of a deceased member of the NJNG who completed initial active duty training and was killed in the performance of his or her duties while a member of the New Jersey National Guard.

Veterans get help from special clinical and research program at the VA

The War Related Illness and Injury Study Center at the East Orange campus of the VA New Jersey Health Care System (NJ WRIISC) is a national center for post-deployment health concerns.

The highest priority is to help returning veterans get the best care they deserve. The NJ WRIISC accomplishes this through an extensive clinical and educational programs for veterans with difficult to diagnose symptoms and exposure related concerns, as well as targeted research programs.

This research important to veteran care because often, it can answer questions about causality or lead to new and innovative treatment approaches. The NJ WRIISC has an impressive research program that is focused on translating findings on veteran health into improved clinical care.

Right now, the center is performing cutting edge research on post-traumatic stress disorder (PTSD), blast-related injury, concussions, fatigue and the effects of exposure to burn pits and sand storms.

Current projects include working with NASA and academic centers such as Harvard University and Johns Hopkins, to utilize the most advanced testing systems to better understand post-deployment health problems.

The center is exploring new avenues of treatment such as integrative medicine programs like yoga and Qi Gong. Veterans participation in a WRIISC research project could yield long term benefits to all veterans.
