

### NCO STEPS UP TO BECOME WARRANT OFFICER

New Jersey Army National Guard Staff Sgt. Yetzabel Palma of the Joint Task Force Headquarters and a personnel sergeant for the Family Readiness Group became an official Warrant Officer Candidate March 13.

Her family and other members of the unit stood in attendance as Command Chief Warrant Officer Guy Remig and along with her husband, Sgt. 1st Class Marlon Palma, 50th Infantry Brigade Combat Team, pinned on the WOC rank on her uniform. However, as meaningful as this ceremony was, now Yetzabel Palma must complete Warrant Officer Candidate School and finalize her training by completing Warrant Officer Basic Course.

Palma's path to becoming a Warrant Officer began in May of 2012, when she attended the Warrant Officer Symposium. There she was motivated by the many warrant officers in New Jersey and was particularly moved by the Command Chief Warrant Officer of the National Guard Bureau, Gary Nisker, as well as Remig. Both Nisker and Remig spoke to the many noncommissioned officers who attended the symposium and urged them to step forward and take on the challenge of becoming a warrant officer.

Building on that platform, Remig saw fit to "grow" warrant officers from the State's NCO ranks and established the New Jersey Pre-WOCS course where NCOs like Palma can be trained in leadership, mentorship, and knowledge needed to succeed at WOCS. When asked what his vision was for the pre-WOCS, Remig stated, "my intent for pre-WOCS is to set the candidate for success, not only in WOCS, but throughout their career as a warrant officer".

During the first drill in March, seven NCOs, all in differing phases of the warrant officer selection process, began their training in preparation for becoming a warrant officer. All of the NCOs in attendance appreciated the "wake-up call" from the WOCS cadre and realized that WOCS will be a challenging yet rewarding experience.

Palma said, "the pre-WOCS program is a great program to set the eligible Soldiers back into the training zone with a great cadre team...I am eagerly looking forward to the next drill weekend where we will face



more challenges."


