# MINUTES OF THE SPECIAL MEETING OF THE NEW JERSEY EDUCATIONAL FACILITIES AUTHORITY HELD AT 103 COLLEGE ROAD EAST, PRINCETON, NEW JERSEY ON WEDNESDAY, MARCH 14, 2012

#### ITEMS OF DISCUSSION

# 1. Adoption of Resolution Appointing an Executive Director and Secretary of the Authority

Chairman Jacobs reported that the position of Executive Director had been vacant since James Poole's resignation on July 22, 2011. He advised that Sheryl Stitt had served as the Authority's Interim, then Acting Executive Director and Acting Secretary with responsibility for the day-to-day operations of the Authority. Mr. Jacobs complimented Ms. Stitt on the exemplary job she has done and stated that the Authority never missed a beat.

Mr. Jacobs reported that the Authority now wished to appoint Derek S. Hansel as Executive Director and Secretary of the Authority commencing on April 10, 2012. He reported that Mr. Hansel is a graduate of Dartmouth College and has more than 20 years experience as a public finance professional in private industry and in working with governmental agencies and not-for-profits. Mr. Hansel has served as Head of the Bonding Authority operations for the U.S. Department of Education's Historically Black Colleges and Universities Capital Financing Program and most recently, as the Assistant Chief Financial Officer of the Pennsylvania Turnpike Commission.

Mr. Petrecca moved the adoption of the following entitled resolution:

# RESOLUTION OF THE NEW JERSEY EDUCATIONAL FACILITIES AUTHORITY APPOINTING AN EXECUTIVE DIRECTOR AND SECRETARY OF THE AUTHORITY

### March 14, 2012

WHEREAS: The New Jersey Educational Facilities Authority (the "Authority") was created pursuant to the New Jersey Educational Facilities Authority Law, P.L. 1967, c. 271, N.J.S.A. 18A:72A-1 et seq., as amended and supplemented (the "Act") and authorized to issue its obligations to provide a means for New Jersey public and private colleges and universities

to obtain financing to construct educational facilities as defined in the Act; and

WHEREAS: The Executive Director is an Officer of the Authority, appointed by the Authority, and

serving as the chief executive officer of the Authority, with general supervision of, and

administrative authority over, all of the activities of the Authority; and

WHEREAS: The office of the Executive Director has been vacant since July 22, 2011, when James

Poole resigned that position; and

WHEREAS: The Members of the Authority have not made a formal appointment of an Executive

Director since that time. Rather, to carry on the day-to-day activities of the Authority, the Members of the Authority have appointed an Acting Executive Director and Sheryl A. Stitt

is currently serving in that role; and

WHEREAS: The Members of the Authority, in accordance with the Act and the By-Laws of the

Authority, as amended through April, 2010 (the "By-Laws"), desire to appoint Derek S.

Hansel as the Executive Director of the Authority; and

WHEREAS: The Members further wish that the duties and responsibilities of the Secretary as set forth

in the By-Laws be vested in the Executive Director; and

WHEREAS: Accordingly, in addition to the position of Executive Director, the Members also desire to

appoint Derek S. Hansel as the Secretary of the Authority.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NEW JERSEY EDUCATIONAL FACILITIES AUTHORITY AS FOLLOWS:

SECTION 1. The Members hereby appoint Derek S. Hansel as the Executive Director of the Authority effective as of April 10, 2012 at a starting annual salary of \$136,000 to perform the functions of that office with all duties, responsibilities and authority granted to that office pursuant to the Act, the By-Laws, resolutions of the Members and other applicable laws

and regulations.

SECTION 2. The Members of the Authority hereby appoint Derek S. Hansel as the Secretary of the Authority effective as of April 10, 2012 with the duties and responsibilities of that office

set forth in the Act and By-Laws.

SECTION 3. This Resolution shall take effect in accordance with the Act and replaces all prior

resolutions to the extent inconsistent herewith.
