TROOPER BRIAN DUROSS #5259 OUTSTANDING PERFORMANCE IN A LIFE THREATENING SITUATION

On February 13, 1998, Tpr. Duross was detailed to assist in securing a crime scene in the City of Camden. A vehicle attempted to enter the well marked barricaded area. The driver of the vehicle failed to comply with his verbal orders to stop and continued to enter the area. Fearing for the safety of fellow troopers and other law enforcement officers that were processing the scene, and with total disregard for his own personal safety, Tpr. Duross reached inside the moving vehicle. The vehicle continued to accelerate at which time Tpr. Duross held onto the vehicle in an attempt to gain control of the driver. His efforts gave the other personnel at the scene warning of the approaching danger, affording them the opportunity to seek cover.

Tpr. Duross' courageous action reflects great credit upon himself and the New Jersey State Police.

Tpr. Abradi and other troopers responding to the scene, entered the water without hesitation in an attempt to rescue the occupant from the vehicle. After numerous attempts to break the windows of the vehicle had failed, troopers continued to enter the frigid water to attach ropes and chains to the vehicle so it could be towed to shore. Exposing themselves to hyperthermia, State Police personnel repeatedly entered the water over a 45 minute period to assist with the rescue operation. With the help of emergency rescue equipment, the vehicle was removed from the water just enough to allow personnel to break the side window and remove the child from the vehicle. Despite the heroic efforts of all personnel involved the victim did not survive.

TROOPER ANGELO J. ARMAGNO #5026 OUTSTANDING PERFORMANCE DURING A MEDICAL EMERGENCY

On February 14, 1999, Tpr. Armagno was detailed to assist with a sick patron at the Essex Toll Plaza, Garden

State Parkway. A female passenger had suffered an apparent heart attack. Tpr. Armagno quickly assessed the victim's condition and with the assistance of a toll collector, began Cardiopulmonary Resuscitation. The victim regained a weak pulse and a request for advanced medical personnel was made. Before the paramedics could arrive, the victim again went into cardiac arrest. Tpr. Armagno again administered CPR until the paramedics could stabilize the patient. The victim was taken to Mountainside Hospital where she was admitted for further treatment.

Tpr. Armagno's quick and decisive action in rendering first aid reflects great credit upon himself and the New Jersey State Police.

TROOPER WALTER M. BABECKI #5556 RESCUE ATTEMPT FROM A FULLY SUBMERGED VEHICLE

On January 11, 1998, a vehicle first thought to be stolen with a sleeping nine year old child inside was later discovered to have rolled into the Rising Sun Lake, Millstone Township and was completely submerged. Tpr. Babecki and other troopers responding to the scene, entered the water without hesitation in an attempt to rescue the occupant from the vehicle. After numerous attempts to break the windows of the vehicle had failed, troopers continued to enter the frigid water to attach ropes and chains to the vehicle so it could be towed to shore. Exposing themselves to hyperthermia, State Police personnel repeatedly entered the water over a 45 minute period to assist with the rescue operation. On February 3, 1997, while on routine patrol of the New Jersey Turnpike in Elizabeth, Tpr. I Beyers observed a truck disabled on the shoulder. Approaching the vehicle, Tpr. I Beyers noticed an individual waving his arms trying to get his attention. The individual advised Tpr. I Beyers that the driver of the truck was unconscious and not breathing. After requesting paramedics to respond to the scene, Tpr. I Beyers evaluated the victim's condition and administered Cardiopulmonary Resuscitation. Within minutes the victim began to respond with his breathing and pulse returning. The victim was taken to the hospital where he underwent emergency surgery to repair a ruptured aneurysm of his aorta.

Tpr. I Beyer's quick and decisive action reflects great credit upon himself and the New Jersey State Police.

DETECTIVE I SEAN N. BOERO #4597
DILIGENT AND PRODUCTIVE
INVESTIGATIVE WORK

During the past twelve months while assigned to the Electronic Investigations Squad, Det. Boero was responsible for eight search warrants, one dial number retriever order, one communications data warrant, and one order to intercept wire communications. This exemplary investigative work resulted in the seizure of \$37,492 and the arrest of 17 persons on various criminal charges as the result of seven lengthy investigations. Det. Boero has displayed the ability to identify and target both traditional and nontraditional organized crime. His reputation for hard work and results have served to establish productive relationships with numerous local, state and Federal law enforcement agencies.

SERGEANT HUGH J. BOYD III #3958
OUTSTANDING PERFORMANCE IN A LIFE
SAVING ENCOUNTER

On August 8, 1998, Sgt. Boyd was on duty at the Governor's residence on Island Beach State Park. He observed three males enter the water in an attempt to swim to a sandbar approximately 40 yards from shore. The three swimmers stopped about two thirds of the way and turned around to swim back to shore. One of the swimmers, drifted apart from the others and was apparently having difficulty. Sgt. Boyd entered the water and swam to the distressed swimmer. Just as he reached the area, the victim slipped below the surface of the water. Sgt. Boyd pulled the victim

from under water and assisted him until the lifeguard arrived. Both the lifeguard and Sgt. Boyd helped return the man to the safety of the shore.

Sgt. Boyd's courage and decisive action, without regard for his own personal safety reflects great credit upon himself and the New Jersey State Police.

TROOPER DEAN A. CARNIVAL # 5569
RESCUE OF OCCUPANTS FROM A BURNING
VEHICLE

On August 21, 1999, Tpr. Carnival and Tpr. I John O'Hara # 3270 were detailed to a two vehicle accident in Buena Vista Township. One of the vehicles was engulfed in flames within the engine compartment. The right front passenger was trapped in the car and seriously injured. Without hesitation and risking injury to themselves, both troopers extinguished the fire and rendered first aid to the victim which included applying a tourniquet to his right arm to control severe bleeding.

Tpr. I O'Hara's quick and decisive action reflects great credit upon himself and the New Jersey State Police.

TROOPER JOSEPH CARSON #5338
OUTSTANDING PERFORMANCE IN A LIFE
SAVING ENCOUNTER

On November 2, 1999, Tpr. Carson responded to a 911 call on the Great Egg Harbor river. A local resident had waded into the river to retrieve his two dogs. As he went further from shore he became stuck in the thick mud. He was unable to free himself as the tide began to rise. Tpr. Carson and local fire and rescue personnel arrived on the scene. Tpr. Carson and a local squad member deployed a boat into the river to help rescue the victim. Their efforts were made more difficult due to a driving rainstorm and the frigid water conditions. As darkness fell, the victim was no longer visible from shore. He was still stuck in the mud and the rising tide had the water level about chest high. Tpr. Carson finally reached the victim and with help from Steven Hale, a member of the Belcoville Rescue Squad, they were able to pull him onto the safety of the boat.

Tpr. Carson's quick and decisive action in this life saving emergency brings great credit upon himself and the New Jersey State Police.

TROOPER WARREN D. DURBIN #5143
QUICK AND DECISIVE ACTION IN AN
EMERGENCY

On March 9, 1998, Tpr. Durbin was detailed to investigate a possible domestic complaint between two females engaged in a physical altercation. Upon arrival, Tpr. Durbin spoke with one of the subjects who stated that her roommate had threatened her for several hours with a knife. She was further concerned because she believed her roommate was locked in their place of residence and was suicidal. With assistance from Tpr. James F. Sansone #5645, they gained access to the home and found the subject hanging from a rope around her neck attached to the kitchen ceiling fan. Both troopers immediately severed the rope and began Car-

diopulmonary Resuscitation. When the rescue breathing mask they were using became inoperative, they continued the procedure in spite of any health risks they may have incurred. The life saving aid Tpr. Durbin provided to the subject sustained her life until she reached the hospital.

Tpr. Durbin's quick and decisive action reflects great credit upon himself and the New Jersey State Police.

**DETECTIVE SERGEANT FIRST CLASS
JOSEPH R. FUENTES #3190
OUTSTANDING PERFORMANCE IN A
DANGEROUS SITUATION**

On June 7, 2000, while en route to his duty assignment, DSFC Fuentes intercepted a radio dispatch from the New Jersey Turnpike of an erratic driver. Shortly thereafter, DSFC Fuentes observed the vehicle traveling at approximately 25 to 40 miles per hour. The suspect's vehicle, which was driving in a hazardous manner on the rims of its tires, failed to stop for the pursuing police vehicles and was followed on to the Garden State Parkway and came to stop at an office complex in Woodbridge Township. The suspect drove the vehicle up to the front entrance of the office building as if he would crash into the front glass doors. Before exiting the vehicle, the suspect reached into the back seat and emerged with a thirteen-inch bloody butcher knife. It was learned earlier that morning he had stabbed his girlfriend during a domestic dispute. As the suspect moved toward the entrance of the building, he held the knife to his throat and made threatening gestures toward the troopers. DSFC Fuentes attempted to communicate with the suspect in Spanish, however he refused to respond. After numerous attempts to persuade the suspect to surrender had failed and fearing that the suspect would assault anyone who happened into or out of the building lobby, the suspect was wounded by another trooper who also responded to the scene.

Throughout this ordeal, DSFC Fuentes exhibited tremendous courage and restraint. His professionalism and decisive action, with complete disregard for his own personal safety, reflects great credit upon himself and the New Jersey State Police.

**TROOPER PATRICK GALLAGHER #5153
DILIGENT PATROL AND CRIMINAL
INVESTIGATIVE WORK**

During the period from January through December of 1997, Tpr. Gallagher initiated 55 separate criminal investigations that resulted in the arrest of 70 persons on some 80 assorted criminal charges. In these cases, the value of recovered property, illicit drugs and other contraband, was estimated to be \$34,000. The majority of these investigations were patrol related and demonstrates an energetic, diligent and alert approach to patrol responsibilities.

This investigation involved a deadly encounter with a drug suspect, resulting in a state police detective and two county investigators being seriously wounded. As a result, danger to the lives of fellow law enforcement and emergency personnel at the scene was minimized.

TROOPER WILLIAM HARKNESS #5355
OUTSTANDING PERFORMANCE IN A LIFE
THREATENING SITUATION

I John Moonan were on patrol within Kingwood Township when they were detailed to investigate the complaint of someone threatening to do damage with a bulldozer. When they arrived at the scene they observed a male subject sitting on a front-end loader bulldozer. In front of the bulldozer was the remains of a vehicle that had been crushed flat. Although Tpr. I Moonan had activated the troop car's overhead lights to get the subject to stop, he continued to drive the bulldozer toward the house. The troop car followed the bulldozer at which point the subject stopped and began to drive the apparatus toward the troop vehicle. Tpr. Moonan then took evasive action to avoid being struck. SERGEANT FIRST CLASS CARMELLO
HUERTAS #3251
APPREHENSION OF A FELON WHILE
OFF DUTY

On November 28, 1998, SFC Huertas was visiting his parent's home in Bethlehem, Pennsylvania. His parents also operate a small grocery which adjoins their residence. While visiting with his grandmother, his daughter burst into the room shouting that someone was robbing the store. SFC Huertas immediately proceeded into the store and was advised that the suspect had just fled on foot out the door. As SFC Huertas ran toward the intersection he observed the suspect, still wearing a ski mask, trying to enter a vehicle. SFC Huertas stood in front of the vehicle and demanded the driver to stop. He observed another female occupant in the rear seat. The suspect was in the front passenger seat yelling at the driver to back up. When the driver exited the vehicle, it began to roll backwards and the suspect attempted to steer the vehicle from the passenger side. Recognizing the possible threat and not sure if the suspect or other occupants had weapons, SFC Huertas reached inside the vehicle in an attempt to remove the suspect. The suspect broke free from his grasp and ran down the street. SFC Huertas was undaunted and continued in pursuit of the suspect until capturing him in the backyard of a local residence. Part of the proceeds from the robbery were found on the suspect's person. He was turned over to the Bethlehem Police Department for processing and was charged with robbery, terrorist threats and aggravated assault.

SFC Huertas' courage and decisive action, without regard for his own personal safety reflects great credit upon himself and the New Jersey State Police.

DETECTIVE I DANIEL HURLEY #3399
OUTSTANDING PERFORMANCE IN A MAJOR
CRIMINAL INVESTIGATION

During a three year period, from 1994 through 1997, Det. I Hurley and other members of the Essex County Official Corruption Task Force spearheaded a major investigation into corruption within municipal government within Essex county. This investigation began with information received from a local merchant that a city official was exporting merchandise from him in an effort to defraud the city of \$10,000. Det. I Hurley and Det. I John Menafra #4085 initiated a surveillance on the target suspect which led to his arrest and conviction on Bribery and Conspiracy charges. As a result, this case dovetailed to a much larger investigation into city and county government eventually reaching to the Prosecutor's office and resulting in numerous arrests.

Det. I Hurley's superior investigative skills coupled with his leadership and devotion to duty is a credit both to himself and the New Jersey State Police.

TROOPER MACH JACKSON #5361
RESCUE OF OCCUPANT FROM A BURNING
VEHICLE

On March 3, 1999 while on patrol on the Garden State Parkway, Tpr. Mach Jackson responded to a motor vehicle accident where a vehicle was fully engulfed in flames with two female occupants trapped inside. As the Tpr. Jackson ran to the burning vehicle, the terrified occupants could be heard screaming for help. Tpr. Jackson observed that the accident had caused the front door to be crimped closed, making escape from the inside impossible. Using only brute strength, he placed one foot on the car and grabbed the door, ripping it open. He then pulled the driver to safety and assisted the other occupant out through the driver's door.

Tpr. Jackson's quick and decisive action, with complete disregard for his own personal safety, reflects great credit upon himself and the New Jersey State Police.

TROOPER I SCOTT JIRAS #3979
OUTSTANDING PERFORMANCE IN A LIFE
THREATENING SITUATION

On December 2, 1997, as a result of a surveillance investigation, DSG Kelly and Det. I Amalio Nieves approached a possible suspect intending to interview him concerning drug trafficking activities. The suspect consented to a search of his residence where \$812,082 in U.S. currency was seized. The subject continued to cooperate with the investigators and agreed to return to his residence waiting for a phone call from a co-conspirator. While both DSG Kelly and Det. I Nieves watched, the suspect grabbed a kitchen knife and began stabbing himself in the chest. Acting immediately and with no regard for their own safety, they struggled to subdue the suspect and disarm him. Once the knife was removed from the suspect's grasp, DSG Kelly and Tpr. I Nieves applied direct pressure to his wound until paramedics could arrive. The suspect was transported to the hospital where he made a full recovery.

**TROOPER SCOTT KILCOMONS #5721
OUTSTANDING PERFORMANCE IN A LIFE
THREATENING SITUATION**

During the period from January through December of 1997, Tpr. I Leone initiated 50 separate criminal investigations that resulted in the arrest of 75 persons on some 70 assorted criminal charges. In these cases, the value of recovered property, illicit drugs and other contraband, was estimated to be \$35,000. On January 11, 1998, a vehicle first thought to be stolen with a sleeping nine year old child inside was later discovered to have rolled into the Rising Sun Lake, Millstone Township and was completely submerged. Tpr. Williams and other troopers responding to the scene, entered the water

without hesitation in an attempt to rescue the occupant from the vehicle. After numerous attempts to break the windows of the vehicle had failed, troopers continued to enter the frigid water to attach ropes and chains to the vehicle so it could be towed to shore. Exposing themselves to hyperthermia, State Police personnel repeatedly entered the water over a 45 minute period to assist with the rescue operation. With the help of emergency rescue equipment the vehicle was removed from the water just enough to allow personnel to break the side window and remove the child from the vehicle. Despite the heroic efforts of all personnel involved the victim did not survive.

Tpr. Williams' quick and decisive action, with complete disregard for his own personal safety, reflects great credit upon himself and the New Jersey State Police.

It appeared that the victim had been involved in an apparent jet-ski accident. Recognizing the urgency of the situation, he entered the water to save the victim. While administering first aid to the injured boater, Tpr. Yannuzzi swam toward the rear platform of his boat where he was assisted by those on board. Once on the vessel, Tpr. Yannuzzi continued to administer first aid and coordinate the response of paramedics to the scene. The victim received 15 sutures to his head and suffered a concussion. If not for the swift and decisive actions of Tpr. Yannuzzi, the victim would have surely drowned.

Over a three year period, from January 1996 through January of 1998, the Criminal Investigation Office assigned to Troop "E" is responsible for several noteworthy investigations. The first case culminated in the arrest of two dangerous felons for three armed robberies they committed on the Garden State Parkway. Information obtained from those arrests netted approximately \$20,000 in stolen property and \$500 in narcotics along with evidence of other crimes. This also resulted in crimes being solved for other police departments as well. The second case began when two troopers made an arrest on an eluding and stolen property investigation. One of the suspects offered information that generated four search warrants and the recovery of stolen property, narcotics, weapons, stolen motor vehicles and confiscated funds totaling \$61,220 and the arrest of six suspects on 40 charges. In addition, they investigated a total of 22 armed robberies, with 14 of those cases resulting in arrests.
