NUMBER OF POSITIONS: Multiple vacancies exist at various institutions throughout the State.

DUTIES: Under direction of the Supervisor of Educational Programs, plans, executes, and evaluates the lessons and educational experiences of the assigned pupils, class, or classes. Performs these duties exercising independent judgment and with a comprehensive knowledge of department rules, regulations, and policies; does related work. **The Office of Education may require teachers to work between sites to address needs of the student population either within a specific region or between Secure Care and Community Programs.**

REQUIREMENTS

EDUCATION: Possession of a valid NJ Teacher's Certificate (Standard, Emergency or Provisional) or Permanent Endorsement, issued by the Board of Examiners of the New Jersey Department of Education, authorizing instruction in subjects areas appropriate to the teaching assignment, as determined by the head of a particular school, district, or institution. **Certification in Teacher of the Handicapped and/or secondary content certification (Math, Science, Social Studies, Physical Education/Health or Career Technical Education) is required.**

NOTE: Teacher 2 is utilized to teach differing student populations and different content areas; therefore, the specific teaching certificate may vary.

SPECIAL NOTE: Emergency Certification may be issued only in the fields of teacher of the handicapped, teacher of the blind and partially sighted and teacher of the deaf and hard of hearing. Provisional Certification is a temporary one-year certificate issued in disciplines other than those appropriate for Emergency Certification, as previously defined.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
