DUTIES: Under direction of the Director or Deputy Director of the Budget and Grant Operations Section and/or an Administrative Analyst 4, performs the review, development and analysis of the Department's budgets and helps prepare recommendations for changes and/or revisions. Performs ongoing analysis for the preparation of spending plans and technical budget documents; does other related duties as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

EXPERIENCE: Three (3) years of experience involving the review, analysis, and evaluation of budget, organization, administrative practices, operation methods, management operations, or data processing applications, or any combination thereof, which shall have included responsibility for the recommendation, planning, and/or implementation of improvements in a business or government agency.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
