NEGOTIATED SETTLEMENT
AGREEMENT

WHEREAS, the named Complainant filed a Verified Complaint with the Division on Civil Rights (Division) alleging that the named Respondent, Clementon Fire & Rescue, committed unlawful discrimination; and

WHEREAS, Clementon Fire & Rescue, is an employer doing business in the State of New Jersey, having a facility at 165 Gibbsboro Road, Clementon, New Jersey, 08021, and as such is subject to the provisions of N.J.S.A. 10:5-1 et seq.; and

WHEREAS, Clementon Fire & Rescue, does not admit that an act of unlawful discrimination occurred, but has submitted to the jurisdiction of the Division in this matter; and

WHEREAS, the Director of the Division has not made any findings based upon the merits of this matter; and

WHEREAS, the parties desire to resolve the matter without the necessity of further litigation;

WHEREAS, the Director of the Division shall execute this Negotiated Settlement Agreement to certify that the covenants contained herein are appropriate to resolve and to insure that all covenants are implemented.

NOW THEREFORE, it is on this 2nd day of August 2010 it is agreed between the parties heretofore mentioned that:

1. Clementon Fire & Rescue, shall continue to comply with the provisions of N.J.S.A. 10:5-1 et seq.; and,
2. Clementon Fire & Rescue, agrees to pay Complainant fifteen thousand dollars (\$15,000) as settlement in this matter; and,
3. Clementon Fire & Rescue agrees to provide Complainant with a positive reference in response to any inquiries about Complainant's work history; and,
4. Clementon Fire & Rescue agrees to provide sexual harassment training to its Clementon Fire & Rescue department members; and,
5. Clementon Fire & Rescue agrees to submit to the Division on Civil Rights a check in the amount of fifteen thousand dollars (\$15,000) payable to Merrisa V. Garretson seven (7) days from the signing of this Agreement. The above amount, the positive letter of reference and sexual harassment training shall represent full satisfaction of all claims of damages rising out of this matter against Clementon Fire & Rescue.




