The Grand Jurors of and for the State of New Jersey,
upon their oaths, present that:

COUNT ONE

(Theft by Deception - Third Degree)

MARY G. RAPKOWICZ

between on or about September 1, 2009 and on or about
August 31, 2011, in the Borough of Point Pleasant, in the
County of Monmouth, elsewhere, and within the jurisdiction
of this Court, purposely did obtain in excess of \$500, from
the New Jersey Department of Labor and Workforce
Development, by deception, that is by creating or
reinforcing a false impression that said MARY G. RAPKOWICZ
was unemployed and eligible to collect unemployment
insurance benefits from the State of New Jersey, to wit: by

submitting false information in her initial application for unemployment benefits in September 2009 and subsequent bi-weekly Claim for Benefits forms between October 2009 and August 2011, by failing to disclose her ownership and management of the Center for Dental and Medical Training, a limited liability company registered under the laws of the State of New Jersey, in the same, or by failing to disclose the hours worked and income generated in this capacity in her bi-weekly Claim for Benefits forms to the New Jersey Department of Labor and Workforce Development between October 2009 and August 2011, contrary to the provisions of N.J.S.A. 2C:20-4(a), and against the peace of this State and the government and dignity of the same.

COUNT TWO

(Tampering with Public Records or Information - Third Degree)

MARY G. RAPKOWICZ

between on or about September 1, 2009 and on or about August 31, 2011, in the Borough of Point Pleasant, in the County of Monmouth, elsewhere, and within the jurisdiction of this Court, with the purpose to defraud or injure, did make a false entry in a record, document or thing belonging to, received or kept by, the government for information or record, or required by law to be kept by others for information of the government, that is, the said MARY G. RAPKOWICZ, knowing the same to be false, did make false entries by failing to disclose her ownership and management of the Center for Dental and Medical Training, a limited liability company registered under the laws of the State of New Jersey, and the hours worked and income generated in this capacity in her initial application for unemployment benefits and subsequent bi-weekly Claim for Benefits forms to the New Jersey Department of Labor and Workforce Development, contrary to the provisions of N.J.S.A. 2C:28-

7(a), and against the peace of this State, the government
and dignity of same.

COUNT THREE

(Unsworn Falsification to Authorities - Fourth Degree)

MARY G. RAPKOWICZ


between on or about September 1, 2009 and on or about August 31, 2011, in the Borough of Point Pleasant, in the County of Monmouth, elsewhere, and within the jurisdiction of this Court, knowingly did make a written false statement which she did not believe to be true on or pursuant to a form, that is, New Jersey Department of Labor and Workforce Development initial application or bi-weekly Claim for Benefits form, said forms bearing notice, authorized by law, to the effect that false statements made therein are punishable, contrary to the provisions of N.J.S.A. 2C:28-3(a), and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Falsifying or Tampering with Records - Fourth Degree)

MARY G. RAPKOWICZ

between on or about September 1, 2009 and on or about August 31, 2011, in the Borough of Point Pleasant, in the County of Monmouth, elsewhere, and within the jurisdiction of this Court, with purpose to deceive or injure another or to conceal a wrongdoing, knowing it to contain a false statement or information, did utter a writing or record, that is, an application for unemployment benefits or subsequent bi-weekly Claim for Benefits forms to the New Jersey Department of Labor and Workforce Development, contrary to the provisions of N.J.S.A. 2C:21-4(a), and against the peace of this State, the government and dignity of same.
