INDICTMENT

GEORGIOS SPYROPOULOS )

The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Conspiracy-First Degree)

GEORGIOS SPYROPOULOS

who is named as a defendant herein, and other persons whose identities are known to the Grand Jurors, who are named as coconspirators but not as defendants herein, between on or about February 26, 2013, and on or about April 9, 2013, at the City of Clifton, in the County of Passaic, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crime of murder and robbery, did agree together and with two persons, whose identities are known to the Grand Jurors, who at all times relevant to this indictment were an agent of the New Jersey State Police and a member of the New Jersey State Police working in an undercover capacity, that:

A. One or more of them knowingly would engage in conduct which would constitute the aforementioned crimes, or

B. One or more of them knowingly would aid in the planning, solicitation or commission of said crimes, that is:

1. Knowingly or purposely cause the death or serious bodily injury resulting in the death of A. S., contrary to the provisions of N.J.S.A. 11-3a(1) and N.J.S.A. 11-3a(2).

2. Knowingly or purposely in the course of committing a theft purposely did attempt to commit a crime of the first or second degree upon A. S., while armed with or threatening the immediate use of a deadly weapon.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Attempted Murder-First Degree)

GEORGIOS SPYROPOULOS

between on or about February 26, 2013 and on or about April 9, 2013, at the City of Clifton, in the County of Passaic, elsewhere and within the jurisdiction of this Court, did knowingly or purposely attempt to cause the death or serious bodily injury resulting in the death of A. S., contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:11-3a(1), (2), and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Attempted Robbery-Second Degree)

between on or about February 26, 2013 and on or about April 9, 2013, at the City of Clifton, in the County of Passaic, elsewhere and within the jurisdiction of this Court, did while in the course of committing a theft purposely attempt to commit or threaten to commit a crime of the first or second degree, that is, murder, upon A. S., contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:15-1a and 1b, and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Possession of a Weapon for an Unlawful Purpose-Second Degree)

GEORGIOS SPYROPOULOS

on or about April 2, 2013, at the City of Clifton, in the County of Passaic, elsewhere, and within the jurisdiction of this Court, did possess a certain weapon, that is a .357 Magnum caliber Taurus Rossi revolver bearing serial number AN462510, with purpose to use it unlawfully against the person or property of another, contrary to the provisions of N.J.S.A. 2C:39-4a and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Unlawful Possession of a Weapon-Second Degree)

GEORGIOS SPYROPOULOS


on or about April 2, 2013, at the City of Clifton, in the County of Passaic, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is a .357 Magnum caliber Taurus Rossi revolver bearing serial number AN462510, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT SIX


(Unlawful Transfer of a Firearm-Fourth Degree)

GEORGIOS SPYROPOULOS

on or about April 2, 2013, at the City of Clifton, in the County of Passaic, elsewhere, and within the jurisdiction of this Court, knowingly did manufacture, transport, ship, sell or dispose of a firearm, that is, a .357 Magnum caliber Taurus Rossi revolver bearing serial number AN462510, without being registered or licensed to do so pursuant to N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d, and against the peace of this State, the government and dignity of the same.
