are named as coconspirators but not as defendants herein, on or about September 11, 2013, at the City of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Unlawful Possession of a Weapon, and/or Unlawful Disposition of a Weapon, did agree together with other persons, whose identities are both known and unknown to the Grand Jurors, who at all times relevant to this indictment was a confidential informant for the New Jersey State Police, that:

- A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or
- B. One or more of them knowingly would aid in the planning, solicitation, or commission of said crimes, that is:
