The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Conspiracy - Second Degree)

JOSEPH MAISONET

who is named as a defendant herein, and another person whose identity is unknown to the Grand Jurors, who is named as a coconspirator but not as a defendant herein, on or about August 2, 2013, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Unlawful Possession of a Weapon, Unlawful Disposition of a Weapon, and Possession of Hollow Nose Bullets, did agree together with other persons, whose identities are known to the Grand Jurors, who at all times relevant to this indictment were agents of the New Jersey State Police, that:

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or

B. One or more of them knowingly would aid in the planning, solicitation, or commission of said crimes, that is:

1. Knowingly possess a certain weapon, that is, a Sig Sauer P226 9mm caliber pistol bearing serial number U149771, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b;

2. Knowingly manufacture, transport, ship, sell, or dispose of a firearm, that is, a Sig Sauer P226 9mm caliber pistol bearing serial number U149771, without being registered or licensed to do so pursuant to N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d; and

3. Knowingly possess a certain weapon or device, that is, hollow nose bullets, contrary to the provisions of N.J.S.A. 2C:39-3f.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Unlawful Possession of a Weapon - Second Degree)

JOSEPH MAISONET

on or about August 2, 2013, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a Sig Sauer P226 9mm caliber pistol bearing serial number U149771, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, N.J.S.A. 2C: 2-6, and against the peace of this State, the government, and dignity of the same.

COUNT THREE

(Unlawful Disposition of a Weapon - Fourth Degree)

JOSEPH MAISONET

on or about August 2, 2013, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did manufacture, transport, ship, sell or dispose of a firearm, that is, a Sig Sauer P226 9mm caliber pistol bearing serial number U149771, without being registered or licensed to do so as provided in Chapter 58, contrary to the provisions of N.J.S.A. 2C:39-9d, N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Possession of Hollow Nose Bullets - Fourth Degree)

JOSEPH MAISONET

on or about August 2, 2013, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon or device, that is, hollow nose bullets, contrary to the provisions of N.J.S.A. 2C:39-3f, N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Conspiracy - Second Degree)

JOSEPH MAISONET

ALEJANDRO FAWCETTE

and

NATHAN NIEVES

who are named as the defendants herein, on or about August 6, 2013, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Unlawful Possession of a Weapon, Unlawful Disposition of a Weapon, and Possession of Hollow Nose Bullets, did agree together with other persons, whose identities are known to the Grand Jurors, who at all times relevant to this indictment were agents of the New Jersey State Police, that:

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or

B. One or more of them knowingly would aid in the planning, solicitation, or commission of said crimes, that is:

1. Knowingly possess a certain weapon, that is, a Smith & Wesson .40 caliber semi automatic handgun bearing serial number RAN8865, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b;

2. Knowingly manufacture, transport, ship, sell, or dispose of a certain firearm, that is, a Smith & Wesson .40 caliber semi automatic handgun bearing serial number RAN8865, without being registered or licensed to do so as provided in Chapter 58, contrary to the provisions of N.J.S.A. 2C:39-9d; and

3. Knowingly possess a certain weapon or device, that is, hollow nose bullets, contrary to the provisions of N.J.S.A. 2C:39-3f.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crime, or

B. One or more of them knowingly would aid in the planning, solicitation, or commission of said crime, that is:

1. Knowingly manufacture, transport, ship, sell, or dispose of a certain firearm, that is, .380 caliber bulldog pistol, serial number unknown, without being registered or licensed to do so pursuant to N.J.S.A. 2C:58-1, et. seq.,

contrary to the provisions of N.J.S.A. 2C:39-9d.




