The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Luring/Enticing a Child by Various Means - Second Degree)

ETHAN Z. CHANDLER

between on or about November 16, 2016 and on or about December 1, 2016, at the Township of Belleville, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did attempt, via electronic or any other means, to lure or entice a child, or one who he reasonably believed to be a child, into a motor vehicle, structure, or isolated area, or to meet or appear at any other place, with the purpose to commit a criminal offense with or against the child, contrary to the provisions of N.J.S.A. 2C:13-6a, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Sexual Assault - Second Degree)

ETHAN Z. CHANDLER


between on or about August 1, 2016 and on or about December 1, 2016, at the Township of Belleville, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did commit an act of sexual penetration with another person of at least 13 but less than 16 years of age, specifically Z.A., and the said ETHAN Z. CHANDLER being at least four years older than the victim, contrary to the provisions of N.J.S.A. 2C:14-2c(4), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Criminal Sexual Contact - Fourth Degree)


ETHAN Z. CHANDLER

between on or about August 1, 2016 and on or about December 1, 2016, at the Township of Belleville, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did commit an act of sexual contact, as defined by N.J.S.A. 2C:14-1d, with another person of at least 13 but less than 16 years of age, specifically Z.A., and the said ETHAN Z. CHANDLER being at least four years older than the victim, contrary to the provisions of N.J.S.A. 2C:14-3b, and against the peace of this State, the government and dignity of the same.
