INDICTMENT

The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

#### COUNT ONE

(Leader of a Narcotics Trafficking Network - First Degree)

between on or about December 15, 2016, and on or about May 10, 2017, at the City of Trenton and the Township of Hamilton, both in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did conspire with two or more persons as an organizer, supervisor, financier or manager of at least one other person, to engage for profit in a scheme or course of conduct to unlawfully manufacture, distribute, dispense, bring into or transport in this State cocaine, a Schedule II controlled dangerous substance, and/or heroin, a Schedule I controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-3, and against the peace of this State, the government and dignity of the same.

## COUNT TWO

(Promoting Organized Street Crime - First Degree)

#### SHAWN DAVIS

between on or about December 15, 2016, and on or about May 10, 2017, at the City of Trenton and the Township of Hamilton, both in the County of Mercer, elsewhere, and within the jurisdiction this Court, knowingly did conspire with others of as an organizer, supervisor, financier or manager, to commit one or more of the crimes enumerated in N.J.S.A. 2C:33-30, specifically, Leader of a Narcotics Trafficking Network, in N.J.S.A. 2C:35-3, Distribution of Controlled violation of Dangerous Substances in violation of N.J.S.A. 2C:35-5, and Unlawful Possession of a Weapon During the Commission of Certain Crimes, in violation of N.J.S.A. 2C:39-4.1, contrary to the provisions of N.J.S.A. 2C:33-30, N.J.S.A 2C:5-2, and against the peace of this State, the government and dignity of the same.

4. Knowingly or purposely distribute a Controlled Dangerous Substance, that is, heroin and/or cocaine, in

violation of <u>N.J.S.A.</u> 2C:35-5, while within 500 feet of a public park or public building, contrary to the provisions of  $\dot{N}.J.S.A.$  2C:35-7.1.

All in violation of  $\underline{N.J.S.A.}$  2C:5-2, and against the peace of this State, the government and dignity of the same.
