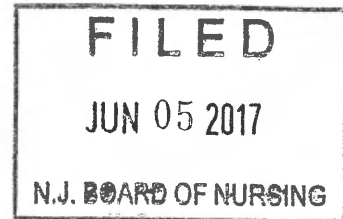

This matter was opened to the New Jersey State Board of Nursing and the New Jersey Board of Pharmacy ("Boards") upon receipt of information which revealed that Radcliffe R. Rose ("Respondent"), holder of an active license to practice as a Registered Professional Nurse and an expired registration as a

Pharmacy Technician in the State of New Jersey, was arrested on May 11, 2017 in Bergen County and charged with violating N.J.S.A. 2C:14-2a(7) (Aggravated Sexual Assault). It is alleged that while practicing as a nurse, Respondent engaged in sexual conduct with a physically helpless and mentally incapacitated person in Wyckoff, New Jersey. Respondent is currently housed in the Bergen County Jail.

The allegations, if proven, would demonstrate that Respondent engaged in acts constituting a crime or offense involving moral turpitude and relating adversely to the practice of nursing and practice as a pharmacy technician pursuant to N.J.S.A. 45:1-21(f). Additionally, the allegations, if proven, would demonstrate that Respondent lacks good moral character which is an underlying foundation for nursing licensure pursuant to N.J.S.A. 45:11-26. Lastly, the allegations, if proven, would demonstrate that Respondent, as a nurse, engaged in sexual misconduct pursuant to N.J.A.C. 13:37-8.3, subjecting him to discipline pursuant to N.J.S.A. 45:1-21 (h) and (c), (d) or (e).

Respondent's registration as a Pharmacy Technician listed an expiration date of August 31, 2010. Any professional or occupational registration not renewed within thirty days of its expiration date shall be suspended without a hearing pursuant to

N.J.S.A. 45:1-7.1(b). As such, Respondent's registration as a Pharmacy Technician was automatically and administratively suspended, without a hearing, on October 7, 2010.

It appearing that Respondent agrees to voluntarily enter into an interim agreement temporarily suspending his nursing license and pharmacy technician registration without making admissions and without prejudice to his ability to defend any action brought based on the above allegations, and the Boards finding the within disposition adequately protective of the public health, safety and welfare; and other good cause having been shown;

IT IS, THEREFORE, ON THIS 5<sup>th</sup> DAY OF June, 2017,

ORDERED AND AGREED THAT:

1. The license to practice as a Registered Professional Nurse and the registration as a Pharmacy Technician in the State of New Jersey, issued to Respondent, Radcliffe R. Rose, are hereby voluntarily surrendered, to be deemed temporarily suspended, effective immediately, pending disposition of the criminal charges detailed above and until further Order of each of the Boards. Respondent shall, contemporaneously with the signing of this Order, forward his nursing license, both wallet and wall versions, to Barbara J.K. Lopez, DAG, P.O. Box 45029,

Newark, New Jersey 07101, on behalf of the Board of Nursing.


2. Respondent shall immediately cease and desist from holding himself out as a nurse or pharmacy technician in the State of New Jersey and shall refrain from the practice of nursing or as a pharmacy technician in the State of New Jersey pending further Order of the Boards.

3. Nothing contained herein shall be deemed an admission of liability on the part of Respondent.


4. The entry of the within Order is without prejudice to the further investigation and/or prosecution of any violations by Respondent of any statutes or regulations governing nursing or pharmacy practice in the State of New Jersey or any other violations of law, by the Boards, the Attorney General, or any other regulatory or law enforcement agency, including, but not limited to, any pending matters under investigation.

5. Nothing herein shall preclude the Boards from initiating further disciplinary action based upon the conduct relating to Respondent as alleged above or upon disposition of the criminal charges. Additionally, the Boards reserve the right to impose discipline, limitations, and/or restrictions at the time of any petition for reinstatement of Respondent's license or registration


