#### **Notice of Extension of Comment Periods for Certain Notices of Proposal Published in the December 21, 2015, New Jersey Register**

**Take notice** that, with the permission and on behalf of the State agencies affected, the Office of Administrative Law announces that the comment periods for the notices of proposal from the Department of Children and Families; the Department of Law and Public Safety, Division of Consumer Affairs, New Jersey State Board of Dentistry; the Department of Corrections; the Board of Public Utilities; the New Jersey Economic Development Authority; and the Casino Reinvestment Development Authority, published in the December 21, 2015, New Jersey Register are hereby extended an additional 14 days.
