### **MAJOR 'SANDY' DEBRIS REMOVED FROM HARRISON RIVERBANK: *PVSC Removes Hazardous Truck Bodies, Cargo Containers from Passaic River***



(HARRISON)— The Passaic Valley Sewerage Commission (PVSC) announced its River Restoration unit recently completed the removal of large debris – including steel shipping/cargo containers, and several delivery truck bodies – that had washed ashore in Harrison during Superstorm Sandy.

PVSC was first notified about a steel shipping container that had washed on shore in Harrison on Cape May Street. Upon investigation of the site, PVSC found two other steel containers and four delivery truck bodies that had suffered the same fate; in addition, three truck bodies and one steel container were on PSE&G property outside their security fence.

Although these are familiar items around the industrial areas in the PVSC service area, they prove problematic to recreational boaters, Harbor masters and River keepers when found in the waterways. PVSC removed the containers and truck bodies with its crane, and then placed them onto transport trailers for return and/or disposal. Recently, PVSC removed 70 cubic yards of debris at an adjacent property, NY/NJ PATH, which was strewn with wood, tires, and plastics from the Superstorm; PVSC also assisted with the removal of two additional truck bodies - one mired in the mud of the Passaic River navigational channel and one on the PATH property.
