Baseline Document Change

Subject: Revision to Section 17 of the Procedures Manual with the addition of New Subsection 17.10 Bridge Replacement and Rehabilitation Program for NON-NHS Roadways.

Section 17 has been revised to include new *Subsection 17.10 Bridge Replacement and Rehabilitation Program for NON-NHS Roadways*. The subsection establishes design policy and procedure and defines the program for the replacement and rehabilitation of deficient bridges on NON-NHS highways in the State of New Jersey.

Additionally, the new subsection will facilitate the design for the replacement or rehabilitation of deficient structures by establishing a program that limits the scope of these projects, limits the right-of-way and environmental impacts necessary to upgrade both the bridge and approach roadways to desirable geometric standards and assures the project will be classified as a categorical exclusion.

Incorporate the following attached revision to the Procedures Manual:

Add new pages **17.10-1** through **17.10-5**.
