Subject: Revision to the 1996 Standard Specifications as amended by the 1998 Supplemental Specifications, Subsection 109.07 Payments following Substantial Completion, BDC00S-4.

Subsection 109.07 is revised for all federally funded contracts in accordance with new DBE Regulations 49 CFR Part 26.29 Subsection (a). This revision requires the Contractor to pay their subcontractors or suppliers amounts due from the current progress payment, including withheld retainage, within 14 days of receipt of payment from the Department.

To incorporate the change, the Standard Input (SI98DOT1) is revised as follows:

INCLUDE THE FOLLOWING FOR FHWA FUNDED PROJECTS.

NOLUDE THE POLLOWING FOR PHWA PUNDED PROJECTS.

SECTION 109 – MEASUREMENT AND PAYMENT

109.07 Payment following Substantial Completion.

SUBPART 1 OF THE FIRST PARAGRAPH IS CHANGED TO:

1. Each subcontractor or supplier has been promptly paid any amount due from any previous progress payment and shall be paid any amount due from the current progress payment, including all retainage withheld from the subcontractor or supplier, within 14 days of the receipt by the Contractor of payment from the Department; or

Instructions to Designers

Effective immediately, these revisions shall be included in all *federally funded contracts*. Department Specification Engineers responsible for preparing the Special Provisions will incorporate the revisions; therefore designers need not insert these changes.
