Baseline Document Change Announcement

Aggregate Products Quality Control Plan

Subject: Revision to the 1996 Standard Specifications as amended by the 1998 Supplemental Specifications, Subsection 106.01, Control of Material, BDC00S-10

Subsection 106.01 is revised to provide minimum requirements, set forth in the "Requirements for an Aggregate Products Quality Control Plan", to be met by aggregate producing facilities supplying materials for NJDOT projects. The Quality Control Plan is intended to assure that all aggregate products produced for NJDOT projects meet applicable established standards and specifications for the use of those products.

To incorporate the change, the Standard Input (*SI98DOT2*) is revised as follows:

SECTION 106 – CONTROL OF MATERIAL

106.01 Source of Supply and Quality Requirements.

THE FOLLOWING IS ADDED BEFORE THE SECOND PARAGRAPH:

Effective January 1, 2001, all aggregate producing facilities supplying materials shall have in place an approved Quality Control Plan which conforms to the minimum requirements of the "Requirements for an Aggregate Products Quality Control Plan". A current copy of the referenced document can be obtained from the Bureau of Materials. Producers who do not have an approved Quality Control Plan will be removed from the Approved Aggregates List, and will not be permitted to supply material.

Instructions to Designers

Effective January 1, 2001, these revisions shall be included in all Department projects. Department Specification Engineers responsible for preparing the Special Provisions will incorporate the revisions; therefore designers need not insert these changes.

Distribution to In-House Staff and Various Public Agencies
